

A total of 944 companies were formed in Oldham in 2011. This total is 3.3% higher than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Oldham when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Oldham when compared to any previous Q4.



November 2011 saw a new record in company registrations in Oldham when compared to any previous November.





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 165 companies were dissolved in Oldham during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 286 companies were added to the company register for Oldham in 2011. This number represents growth of 31.3% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Oldham during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 43 companies.

net growth by quarter






company share by year







director age by year







director gender by year




Half Year Data (Jul-Dec 2011)
