

2011 was a record year for company registrations in Ormskirk when compared to any year in history.

A total of 274 companies were formed in Ormskirk in 2011. This total is 26.9% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Ormskirk when compared to any previous second half year.

In the second half of 2011 a total of 132 companies were formed in Ormskirk. This figure is 21.1% higher than last year, which compares well to the UK wide figure of 14.0%.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Ormskirk when compared to any previous Q4.

A total of 65 companies were registered in Ormskirk during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 47.7% versus the same period last year (Q4 2010). This figure compares well to the UK as a whole, which saw an increase of 15.3% against the same period last year.



#### new companies by month



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 83 companies were dissolved in Ormskirk. This figure is 3.8% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Ormskirk occurred in 2009 when a total of 107 were closed.

#### dissolved companies by half year




A total of 43 companies were dissolved in Ormskirk during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 129 companies were added to the company register for Ormskirk in 2011. This number represents growth of 59.7% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Ormskirk during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 22 companies.

This represents an increase of 214.3% on the same period last year.








#### company share by half year





#### director age by half year



The percentage of directors over the age of 65 was 3.5% compared to the UK figure of 4.1%.


#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)
