
The first half of 2012 saw a new record in company registrations in Orpington when compared to any previous first half year.

The first half of 2012 was a record first half year for company registrations in Orpington when compared to any half year in history.

In the first half of 2012 a total of 337 companies were formed in Orpington. This figure is 20.8% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Orpington occurred in 2012 when a total of 337 were formed.


Quarterly Data (Q2 Apr-Jun 2012)

Q2 2012 saw a new record in company registrations in Orpington when compared to any previous Q2.

A total of 157 companies were registered in Orpington during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 12.1% versus the same period last year (Q2 2011). This figure compares equally to the UK as a whole, which saw an increase of 8.3% against the same period last year.





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)












company share by half year





director age by half year






director age by quarter

director gender by half year


