

In the first half of 2011 a total of 534 companies were formed in Oxford. This figure is 4.5% lower than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Oxford occurred in 2010 when a total of 559 were formed.

#### new companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)





#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)

A total of 170 companies were dissolved in Oxford during the second quarter of 2011 (Apr 2011 - Jun 2011).





#### net growth by half year





Net company growth for Oxford during the second quarter of 2011 (Apr 2011 - Jun 2011) was 103 companies.











## director age by half year





The percentage of directors over the age of 65 was 6.7% compared to the UK figure of 4.3%.


#### director age by quarter

#### director gender by half year




# Quarterly Data (Q2 Apr-Jun 2011)

The record second quarter for female directors in Oxford was in 1866 when 66.7% of all directors were female.

25.5% of all director appointments in Oxford in the second quarter of 2011 were female. This compares to a UK average of 26.1% for the same period.
