
Q1 2012 saw a new record in company registrations in Oxford when compared to any previous Q1.

A total of 308 companies were registered in Oxford during the first quarter of 2012 (Jan 2012 - Mar 2012).

This figure is an increase of 18.0% versus the same period last year (Q1 2011). This figure compares well to the UK as a whole, which saw an increase of 13.0% against the same period last year.



February 2012 saw a new record in company registrations in Oxford when compared to any previous February.




#### new companies by month




Q1 2012 saw a new record in net growth in Oxford when compared to any previous Q1.


#### net growth by quarter







25.2% of all director appointments in Oxford in the first quarter of 2012 were female. This compares to a UK average of 25.3% for the same period.
