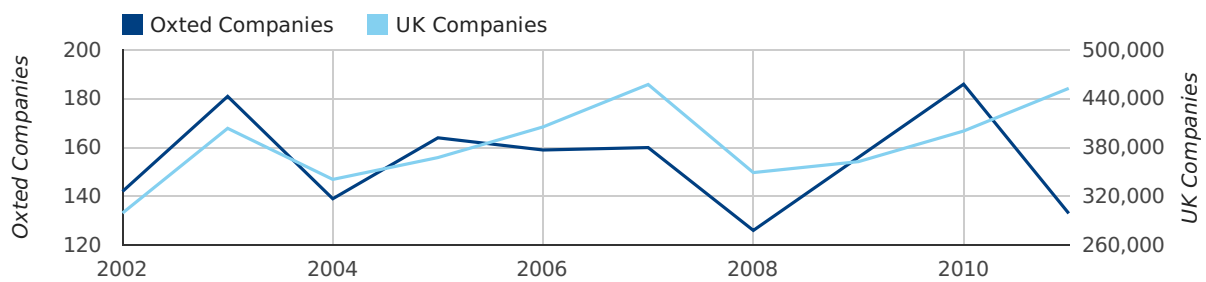

### Annual Data (2011)

A total of 133 companies were formed in Oxted in 2011. This total is 28.5% lower than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.

### new companies by year



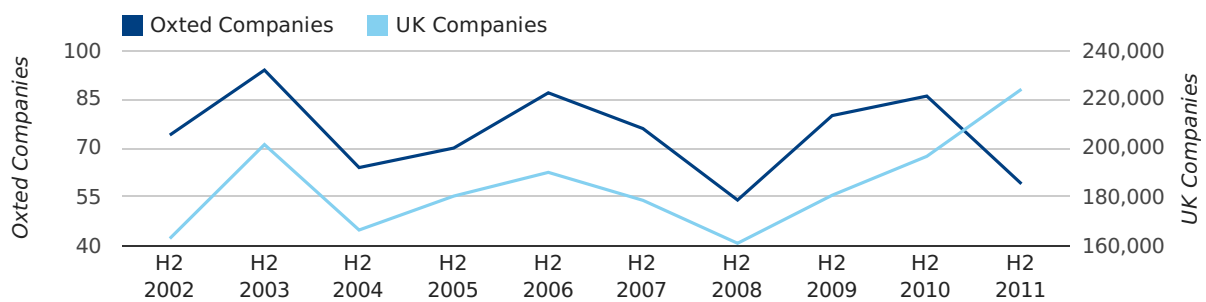
### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 59 companies were formed in Oxted. This figure is 31.4% lower than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Oxted occurred in 2003 when a total of 94 were formed.

### new companies by half year



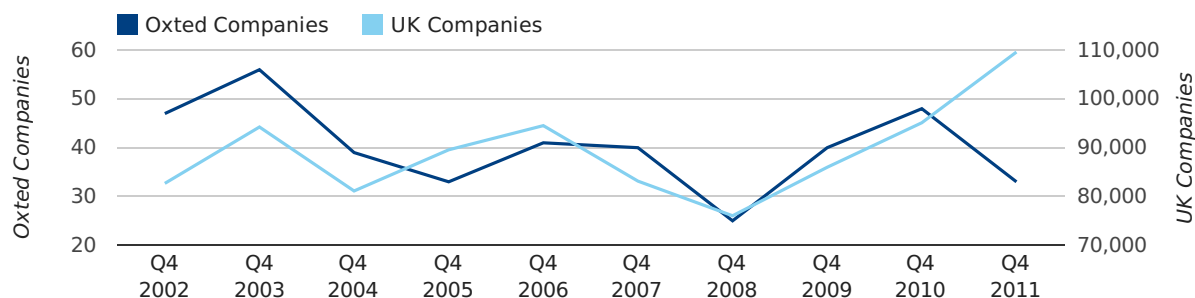
## Quarterly Data (Q4 Oct-Dec 2011)

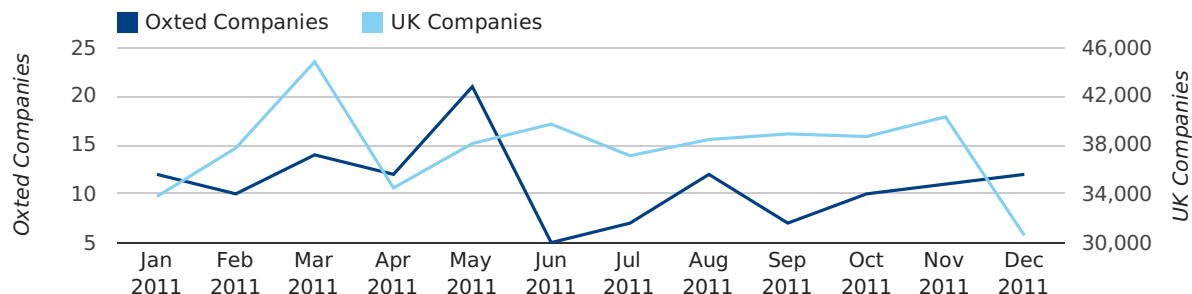

### dissolved companies by year



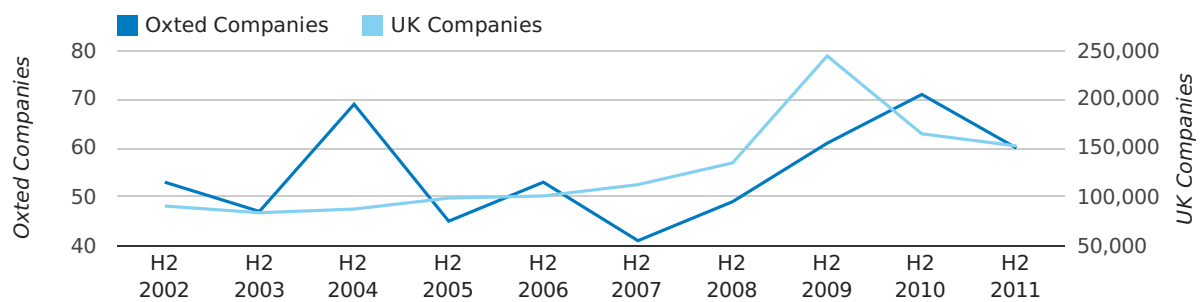
### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 60 companies were dissolved in Oxted. This figure is 15.5% lower than last year, which compares well to the UK wide change of -7.5%.

### dissolved companies by half year



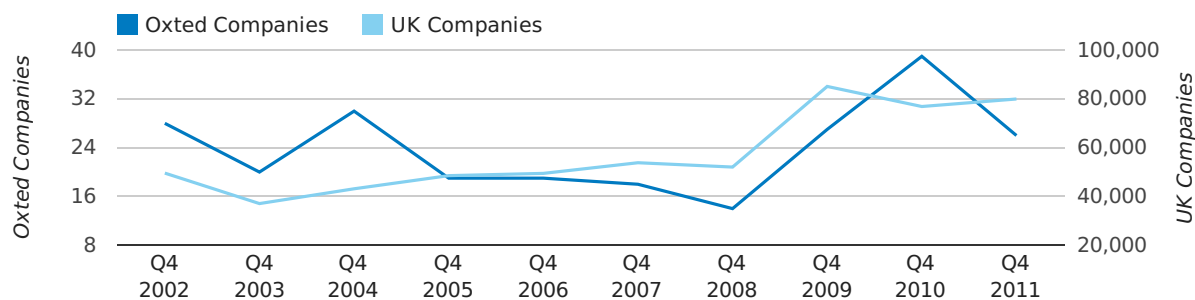
## Quarterly Data (Q4 Oct-Dec 2011)

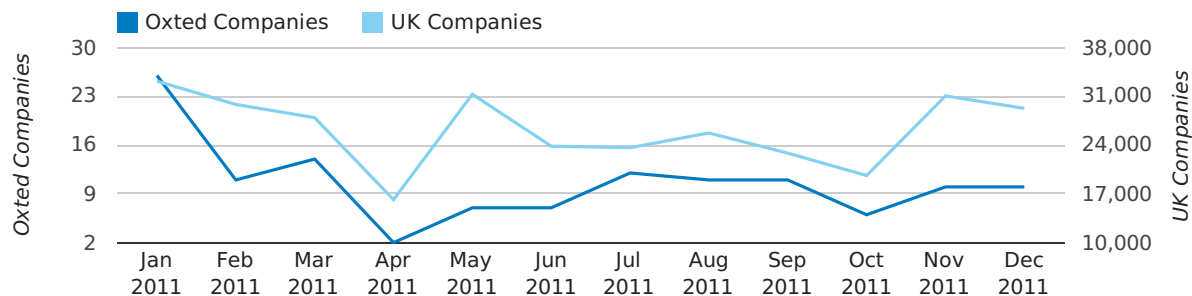

### Annual Data (2011)

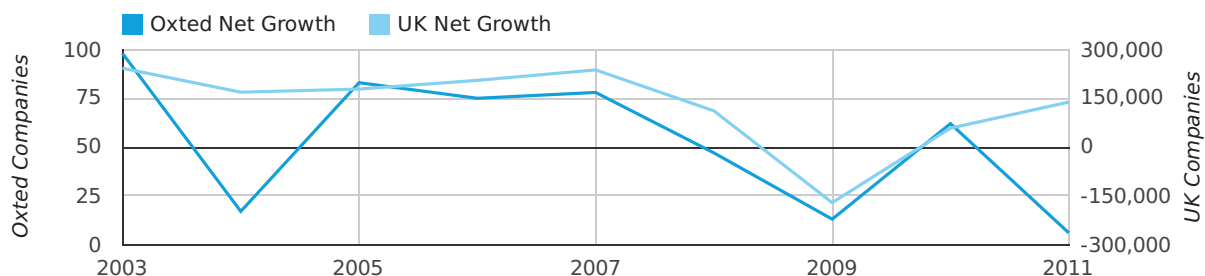
A total of 6 companies were added to the company register for Oxted in 2011. This number represents growth of 3.2% which compares unfavourably to the UK figure of 34.6%.

### net growth by year

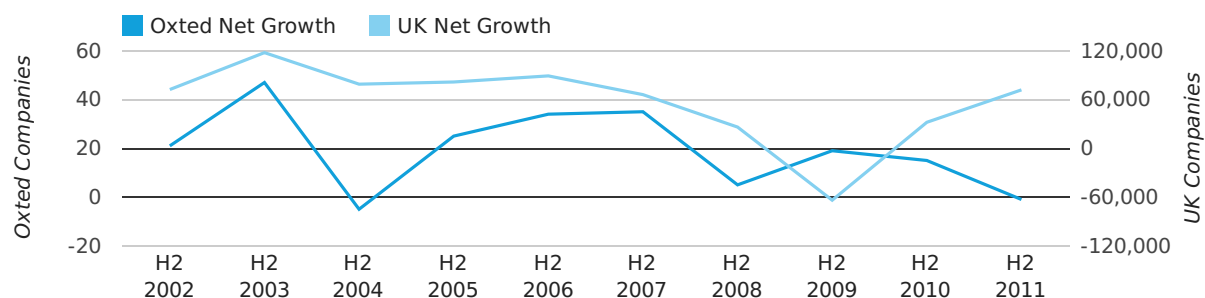


### Half Year Data (Jul-Dec 2011)

### net growth by half year



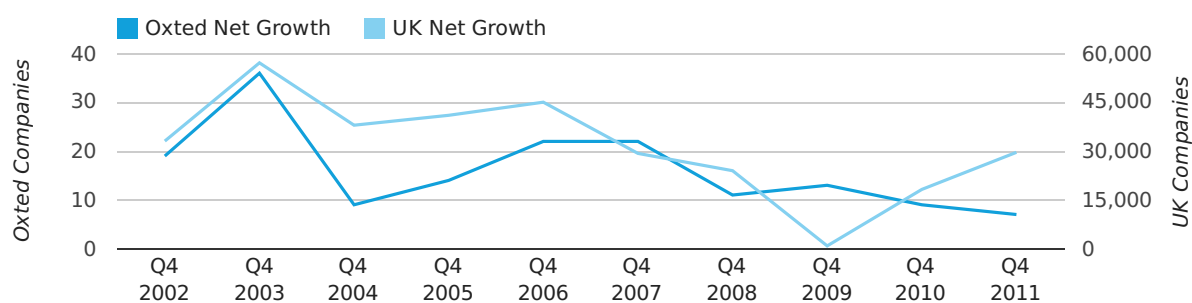
## Quarterly Data (Q4 Oct-Dec 2011)

This represents a decrease of 22.2% on the same period last year.

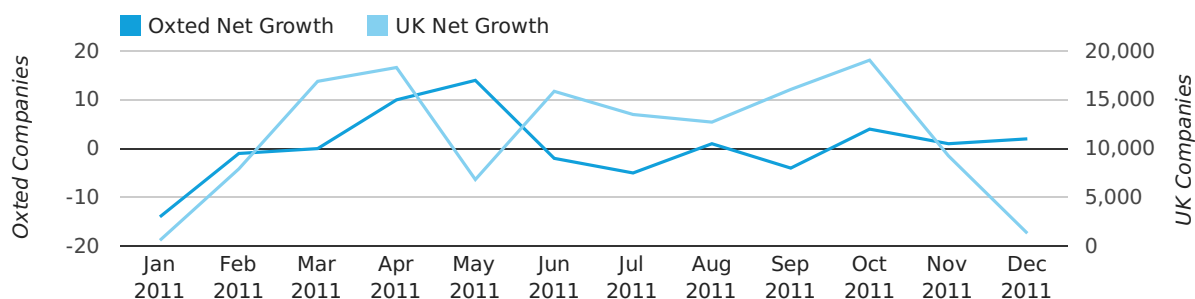

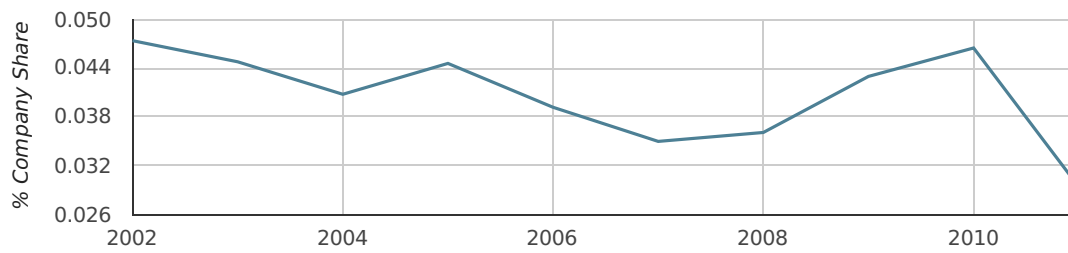

### company share by year

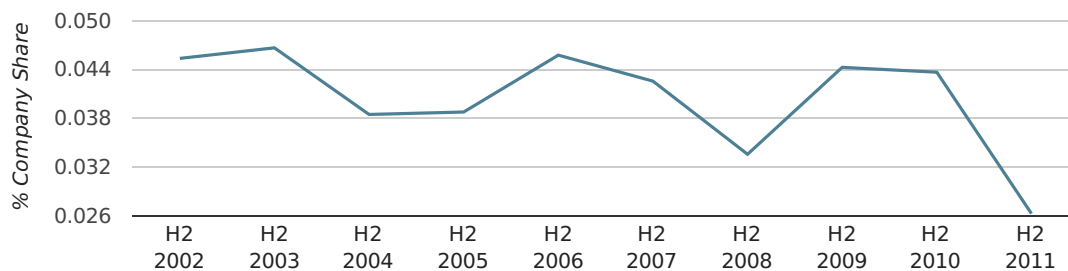

### company share by half year

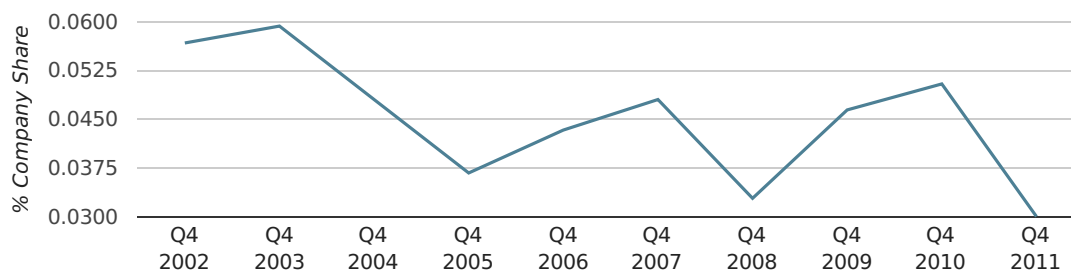

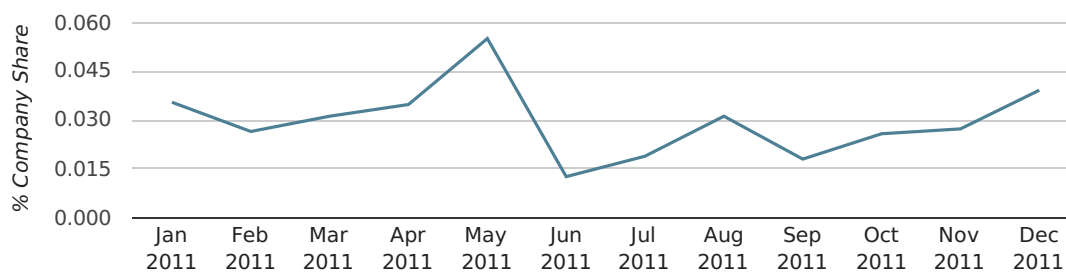

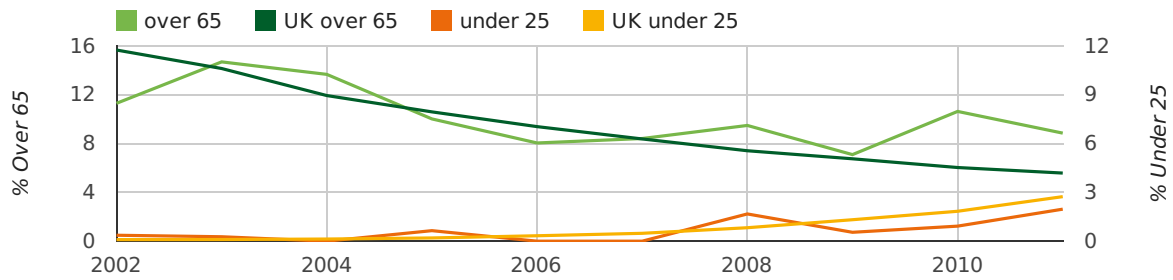

#### director age by year



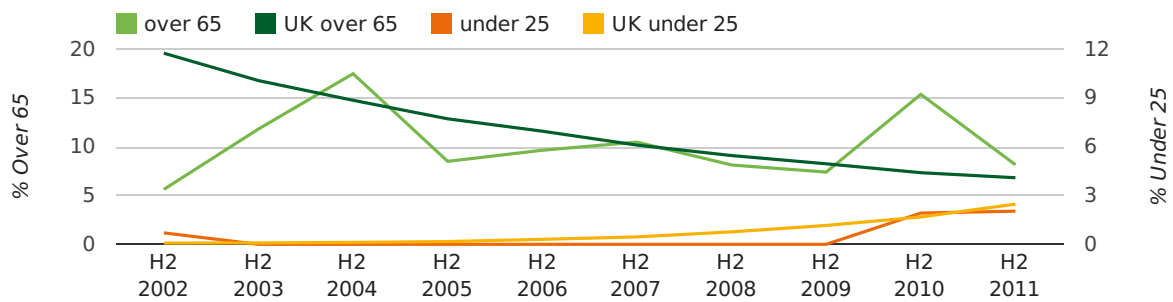
### Half Year Data (Jul-Dec 2011)

#### director age by half year



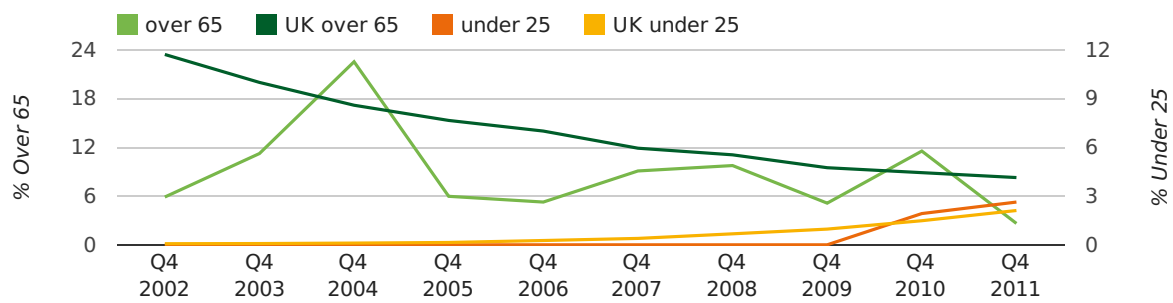

### director age by quarter

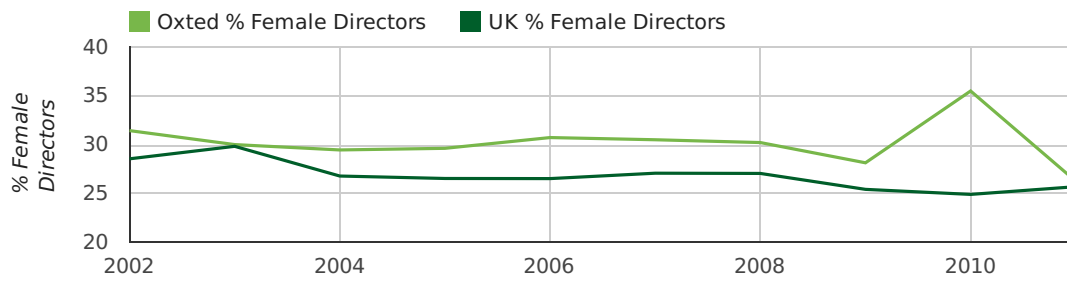


### Annual Data (2011)

#### director gender by year

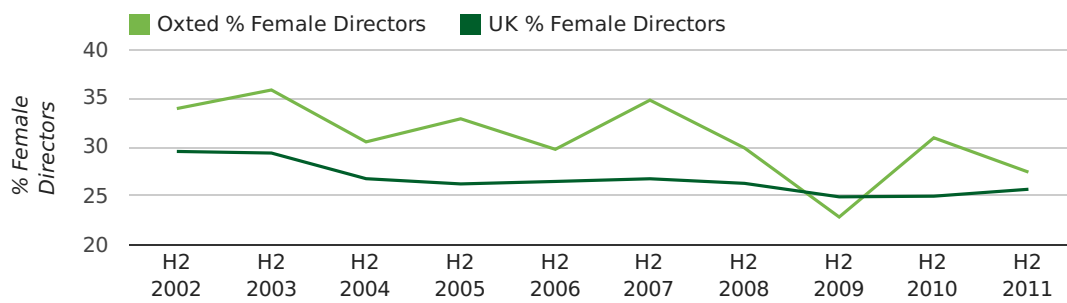


### Half Year Data (Jul-Dec 2011)

#### director gender by half year

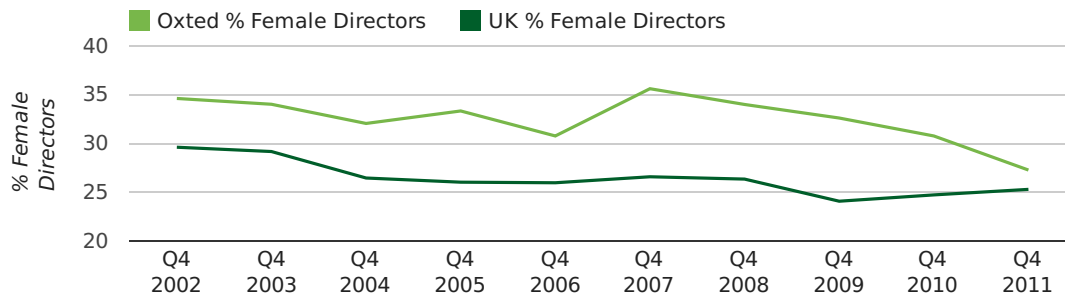


## Quarterly Data (Q4 Oct-Dec 2011)
