




Quarterly Data (Q2 Apr-Jun 2012)



dissolved companies by half year





A total of 34 companies were dissolved in Petersfield during the second quarter of 2012 (Apr 2012 - Jun 2012).







net growth by quarter





company share by half year







director age by half year



The percentage of directors over the age of 65 was 4.0% compared to the UK figure of 3.3%.




director age by quarter

director gender by half year


