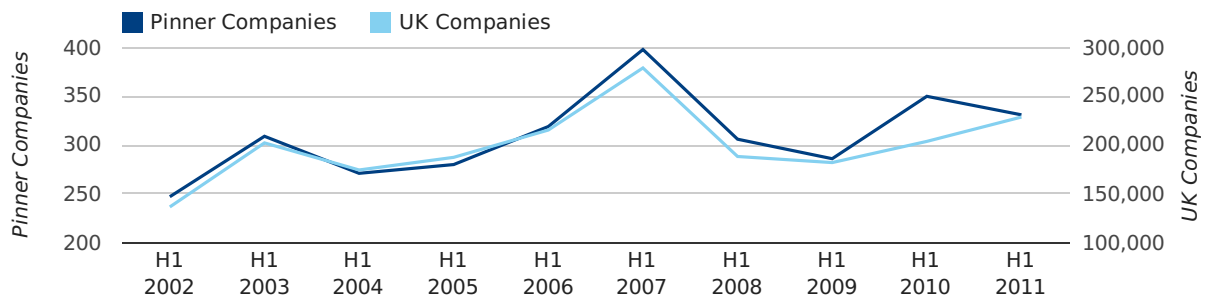
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 331 companies were formed in Pinner. This figure is 5.4% lower than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Pinner occurred in 2007 when a total of 398 were formed.

new companies by half year



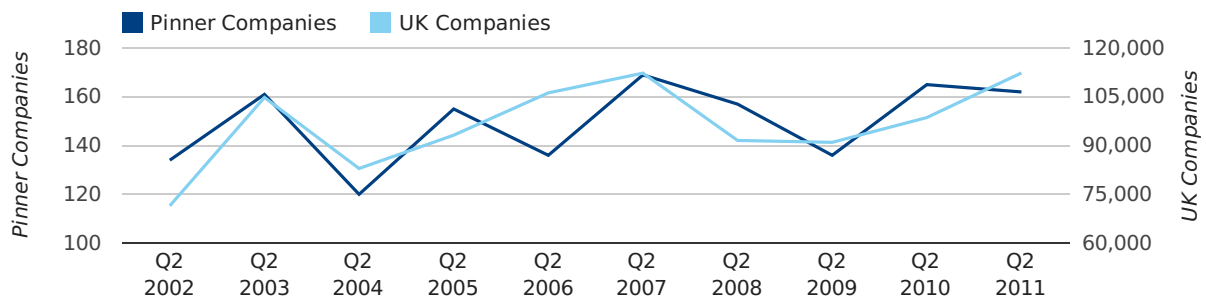
Quarterly Data (Q2 Apr-Jun 2011)

A total of 162 companies were registered in Pinner during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is a decrease of 1.8% versus the same period last year (Q2 2010). This figure compares badly to the UK as a whole, which saw an increase of 13.9% against the same period last year.

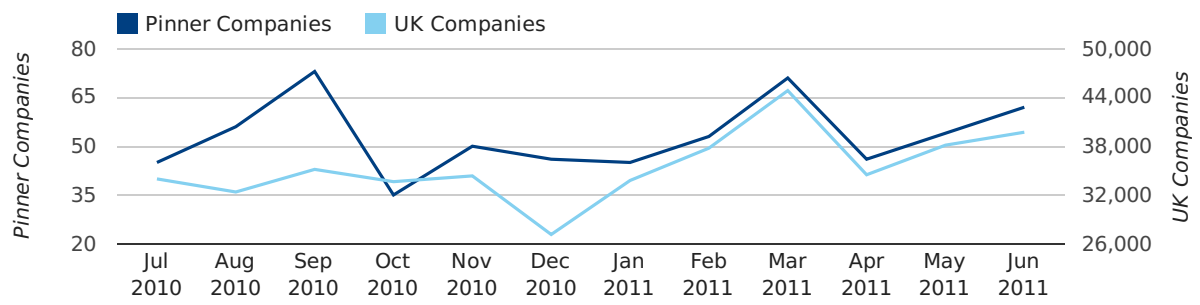
new companies by quarter

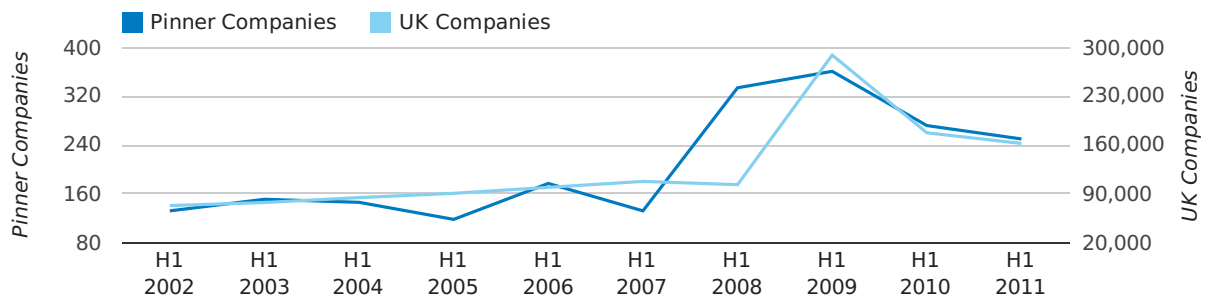
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 250 companies were dissolved in Pinner. This figure is 8.1% lower than last year, which compares badly to the UK wide change of -8.6%.

The highest total for a first half year in Pinner occurred in 2009 when a total of 361 were closed.

dissolved companies by half year



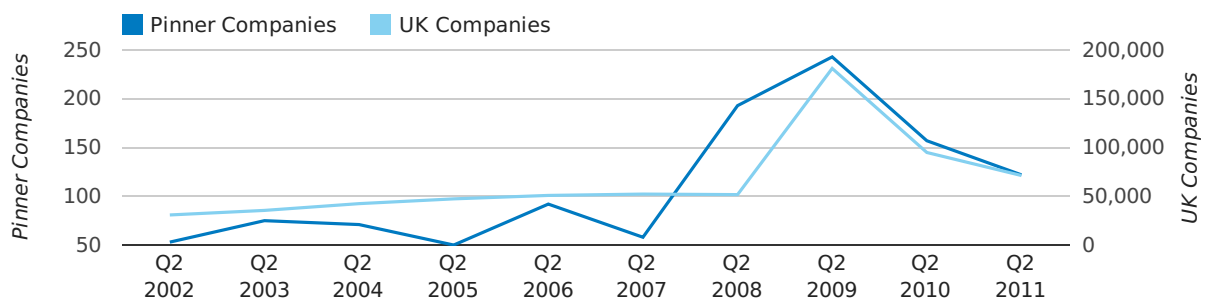
Quarterly Data (Q2 Apr-Jun 2011)

A total of 122 companies were dissolved in Pinner during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is a decrease of 22.3% versus the same period last year (Q2 2010). This figure compares poorly to the UK as a whole, which saw a decrease of 24.9% against the same period last year.

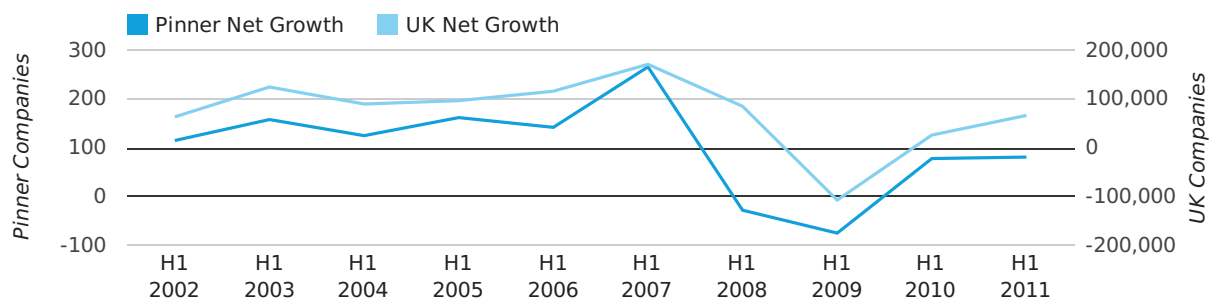

net growth by half year



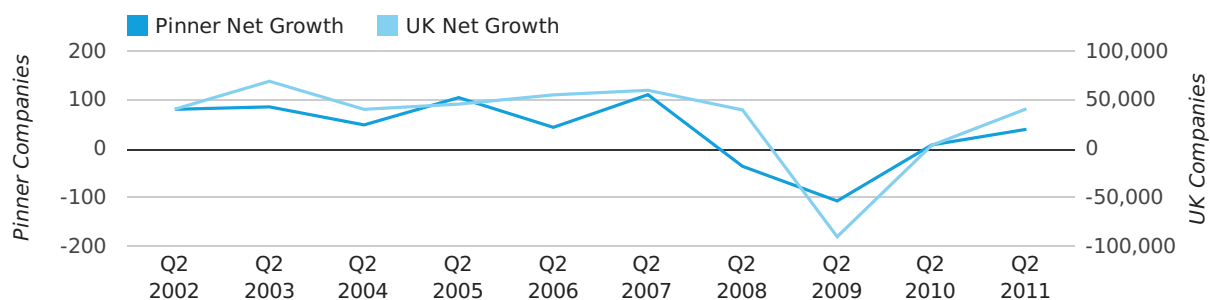

This represents an increase of 400.0% on the same period last year.

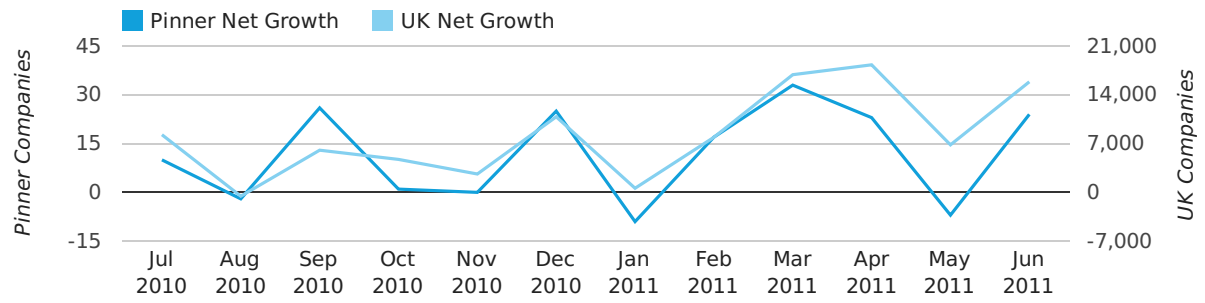

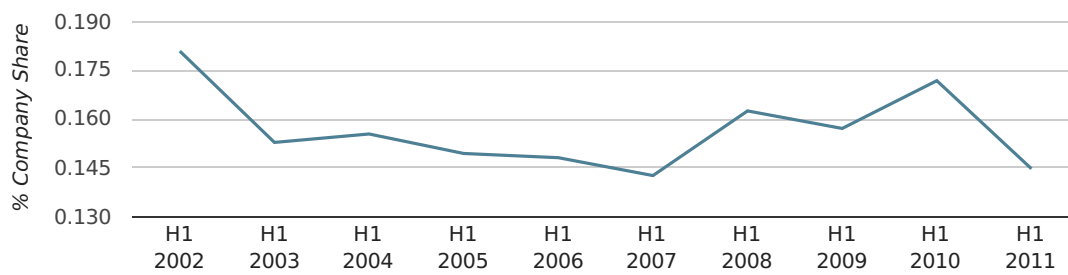

company share by half year

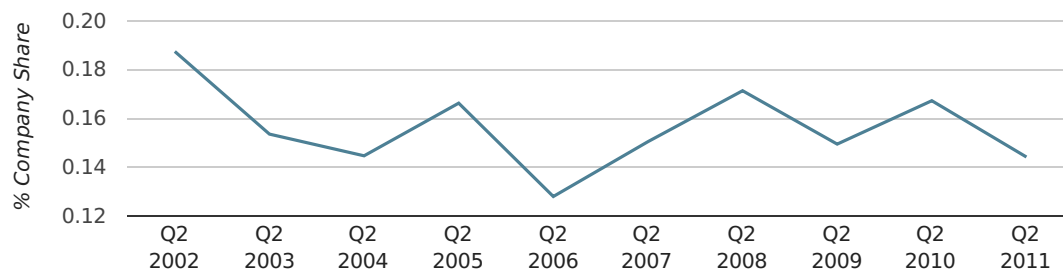

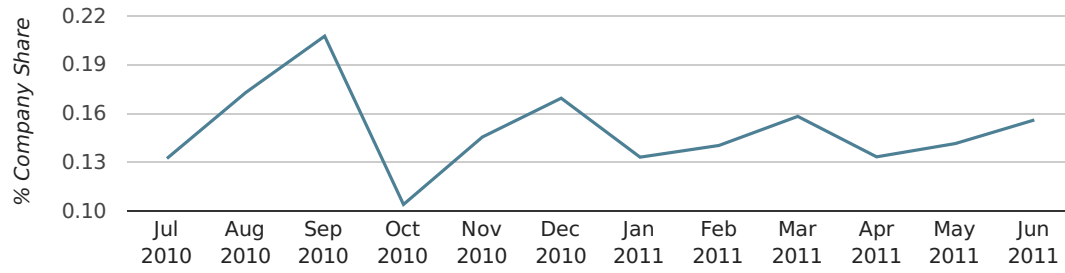

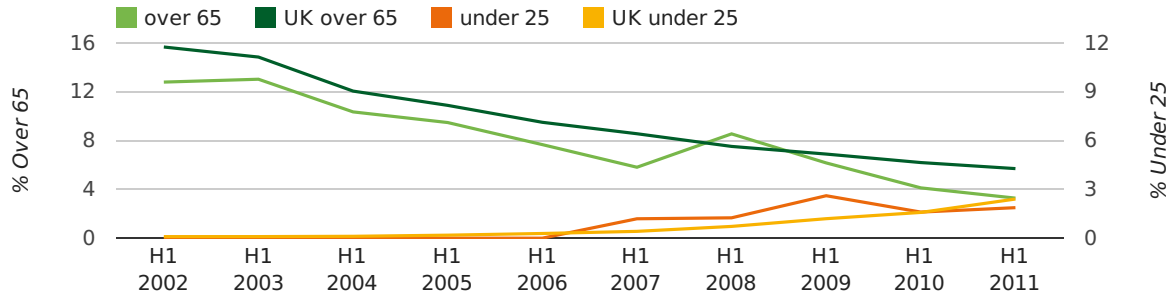

director age by half year



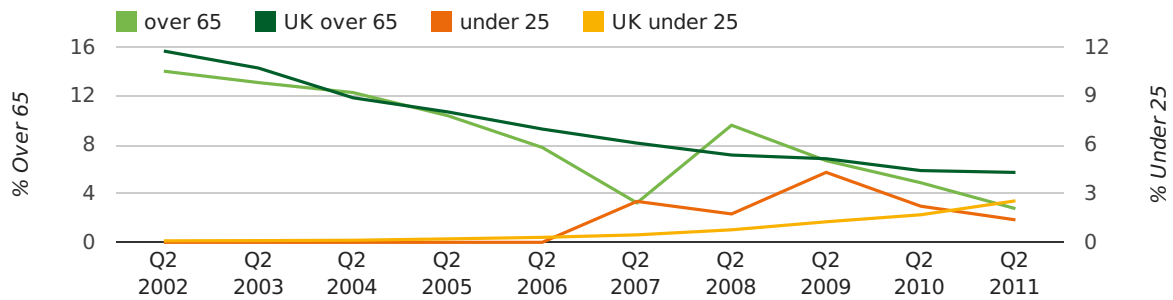

director age by quarter

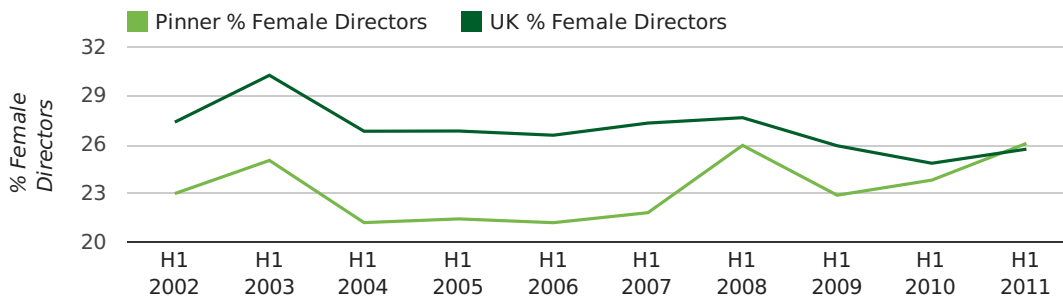


Half Year Data (Jan-Jun 2011)

26.1% of all director appointments in Pinner in the first half of 2011 were female. This compares to a UK average of 25.7% for the same period.

director gender by half year

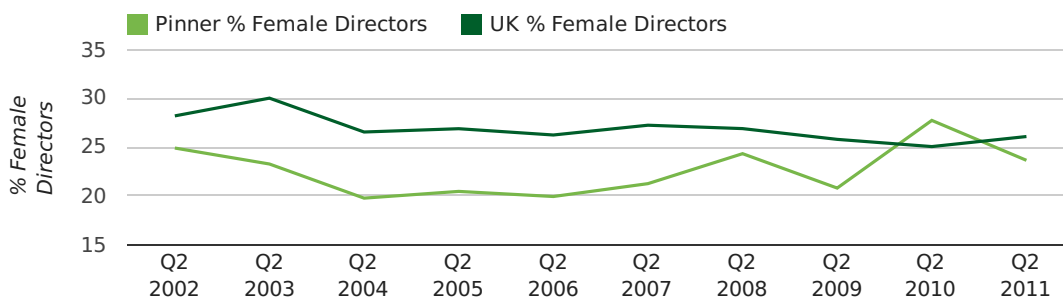


Quarterly Data (Q2 Apr-Jun 2011)
