




Half Year Data (Jul-Dec 2011)




new companies by half year




new companies by quarter








A total of 151 companies were added to the company register for Pinner in 2011. This number represents growth of 23.1% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)






company share by year







director age by year





director age by half year



The record second half year for female directors in Pinner was 1860 when 42.9% of all directors were female.


