

A total of 120 companies were formed in Prenton in 2011. This total is 51.9% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Prenton when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Prenton when compared to any half year in history.

#### new companies by half year




## Quarterly Data (Q4 Oct-Dec 2011)

Q4 2011 saw a new record in company registrations in Prenton when compared to any previous Q4.



#### new companies by month



dissolved companies by year




# Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 31 companies were dissolved in Prenton. This figure is 41.5% lower than last year, which compares well to the UK wide change of -7.5%.

#### dissolved companies by half year




A total of 9 companies were dissolved in Prenton during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 55 companies were added to the company register for Prenton in 2011. This number represents growth of 69.6% which compares favourably to the UK figure of 34.6%.

#### net growth by year




## Half Year Data (Jul-Dec 2011)

#### net growth by half year




Q4 2011 saw a new record in net growth in Prenton when compared to any previous Q4.


#### net growth by quarter

#### net growth by month




company share by year







#### director age by year





## director age by half year



#### director gender by year




# Half Year Data (Jul-Dec 2011)
