


In the first half of 2012 a total of 908 companies were formed in Preston. This figure is 7.1% higher than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Preston occurred in 2003 when a total of 995 were formed.

#### new companies by half year




# Quarterly Data (Q2 Apr-Jun 2012)

A total of 447 companies were registered in Preston during the second quarter of 2012 (Apr 2012 - Jun 2012).





#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2012)

A total of 284 companies were dissolved in Preston during the second quarter of 2012 (Apr 2012 - Jun 2012).





### net growth by half year





Net company growth for Preston during the second quarter of 2012 (Apr 2012 - Jun 2012) was 163 companies.











### director age by half year




# Quarterly Data (Q2 Apr-Jun 2012)

The percentage of directors over the age of 65 was 1.4% compared to the UK figure of 3.3%.


#### director age by quarter
