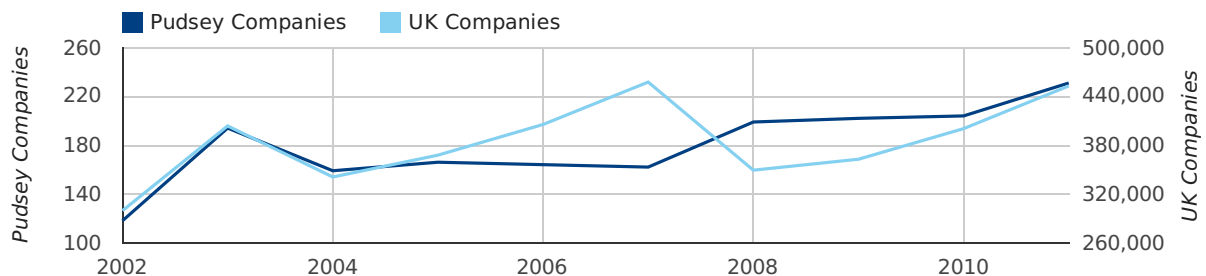
## Annual Data (2011)

2011 was a record year for company registrations in Pudsey when compared to any year in history.

A total of 231 companies were formed in Pudsey in 2011. This total is 13.2% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

### new companies by year



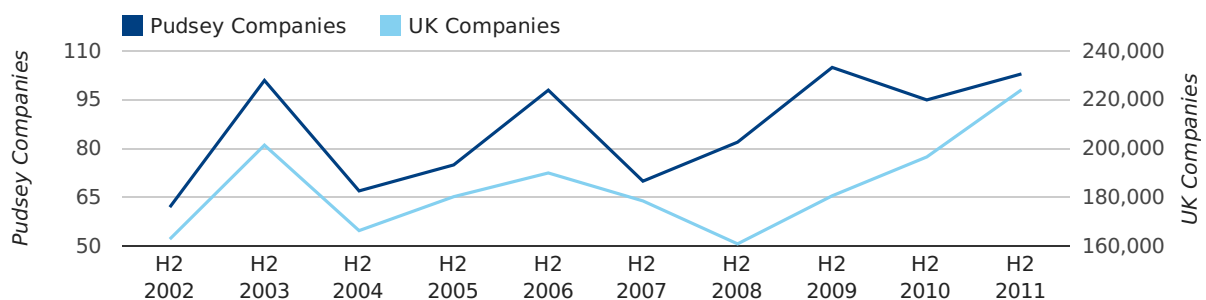
## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 103 companies were formed in Pudsey. This figure is 8.4% higher than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Pudsey occurred in 2009 when a total of 105 were formed.

### new companies by half year



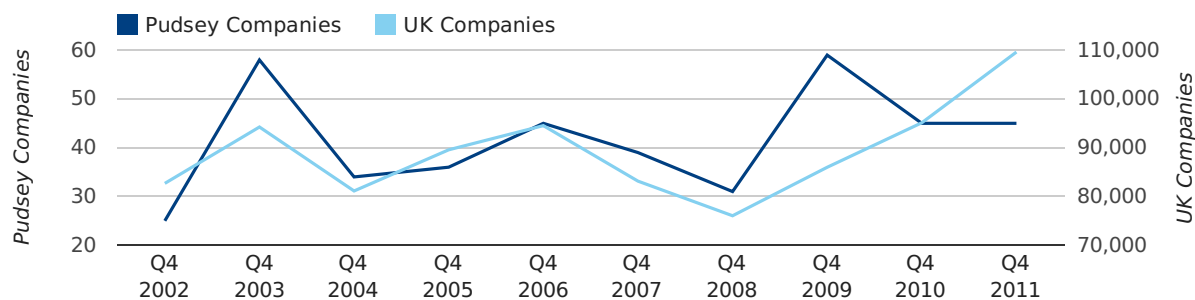
## Quarterly Data (Q4 Oct-Dec 2011)

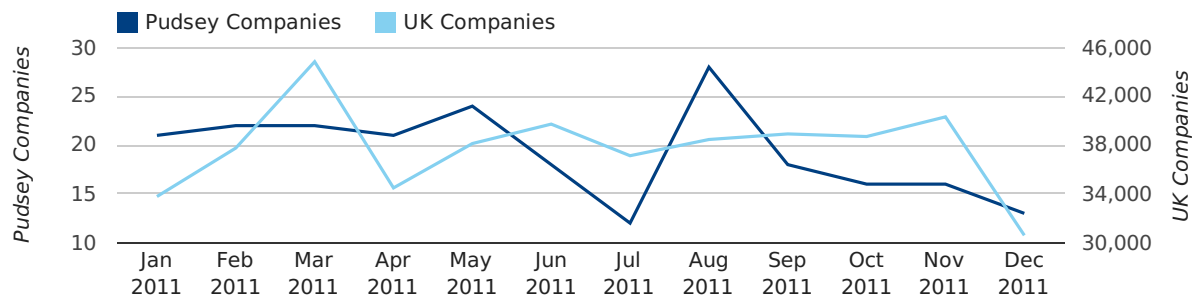

### Half Year Data (Jul-Dec 2011)

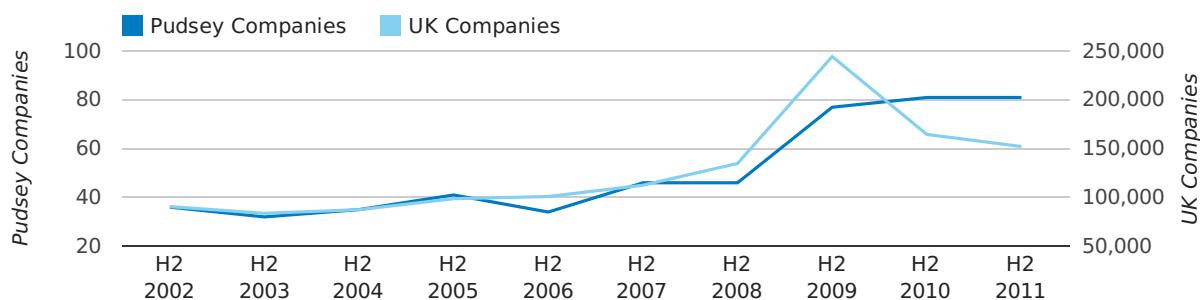
The second half of 2011 saw a new record in company closures in Pudsey when compared to any previous second half year.

### dissolved companies by half year



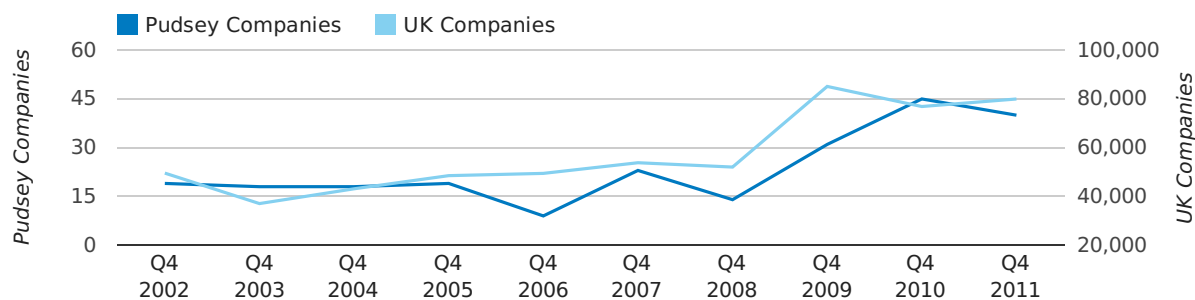
## Quarterly Data (Q4 Oct-Dec 2011)

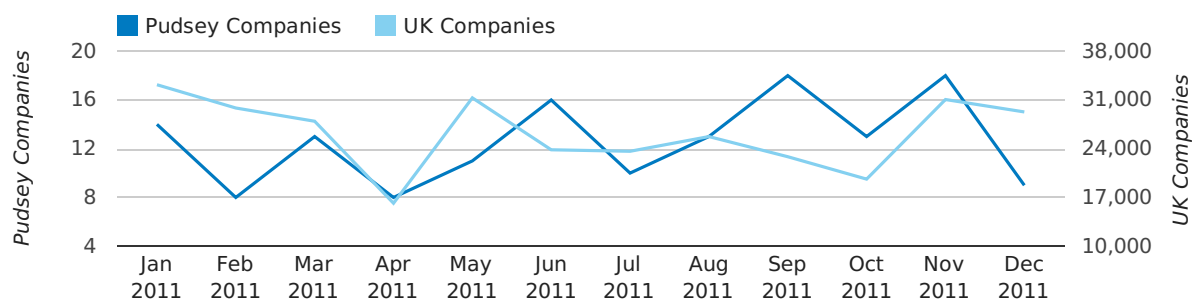
### dissolved companies by quarter

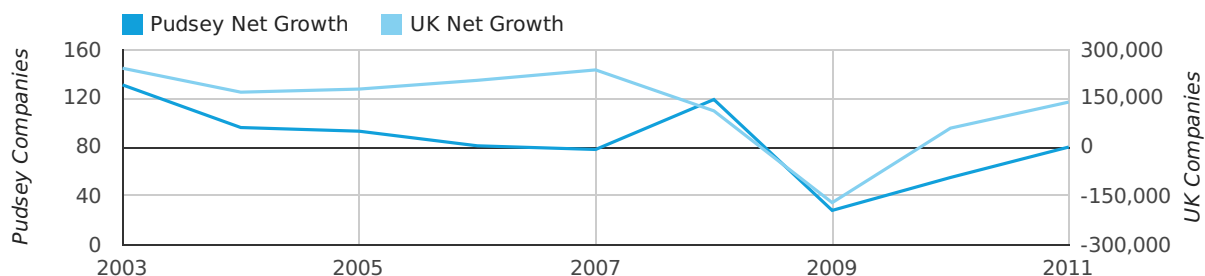
A total of 80 companies were added to the company register for Pudsey in 2011. This number represents growth of 39.2% which compares favourably to the UK figure of 34.6%.

### net growth by year

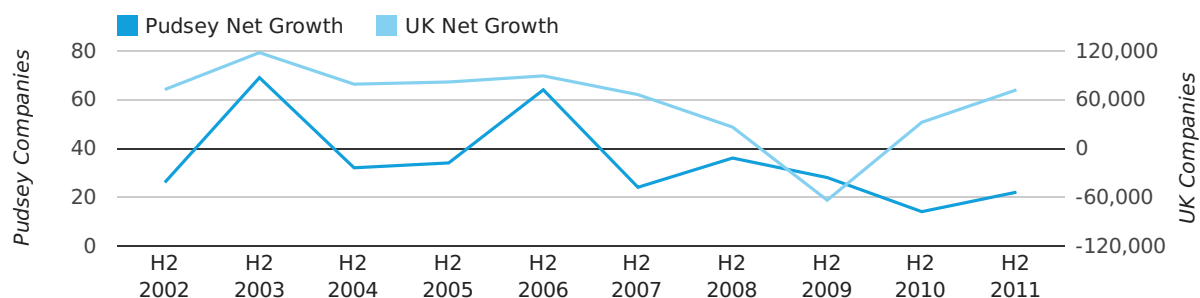


### Half Year Data (Jul-Dec 2011)

### net growth by half year



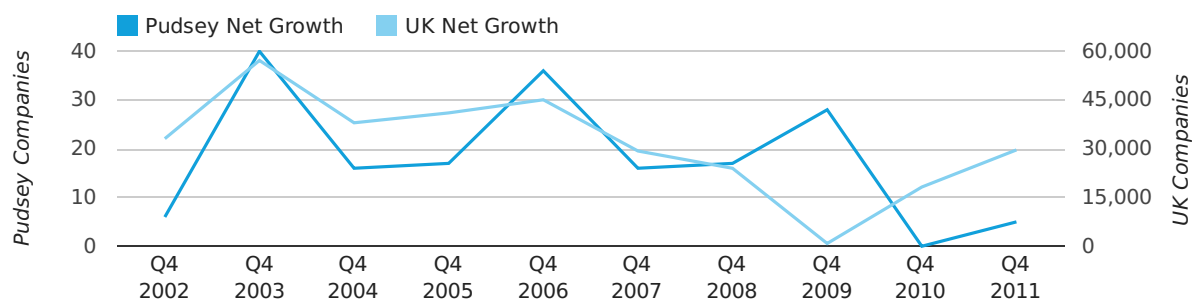

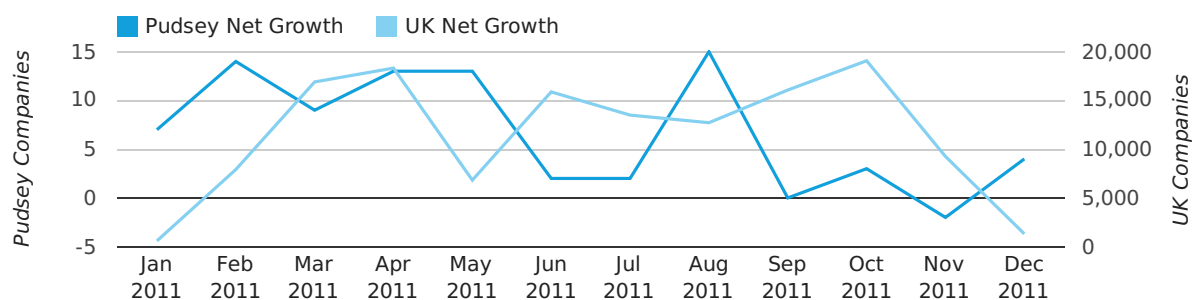

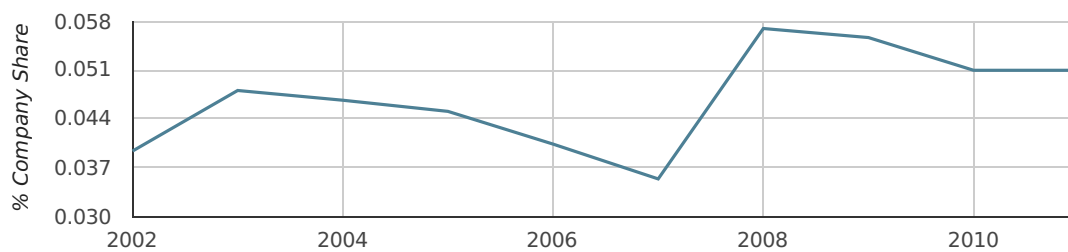

### company share by year

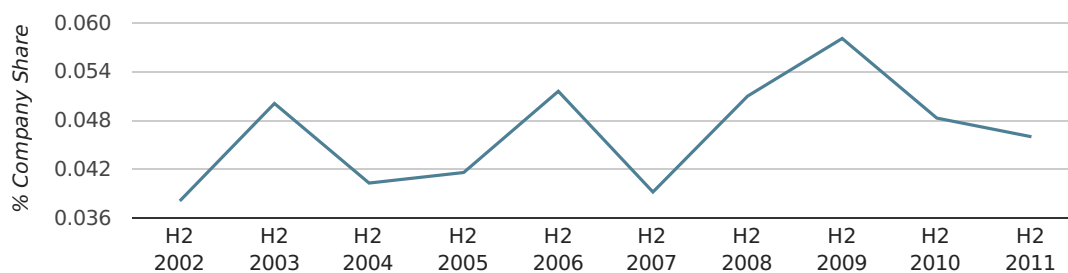

### company share by half year

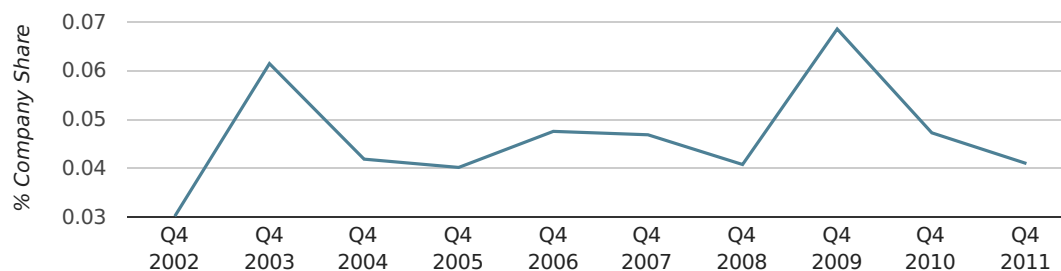

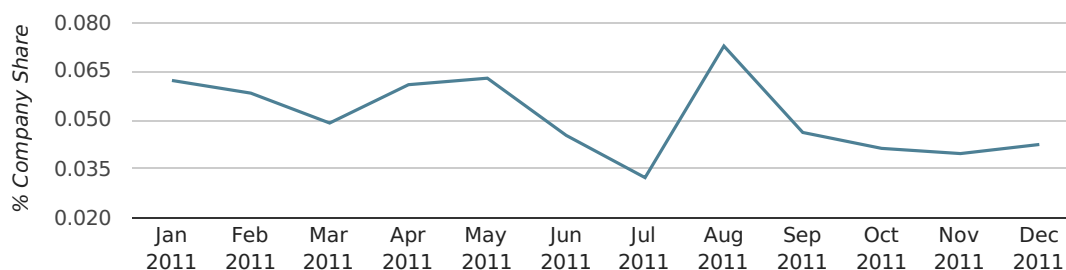

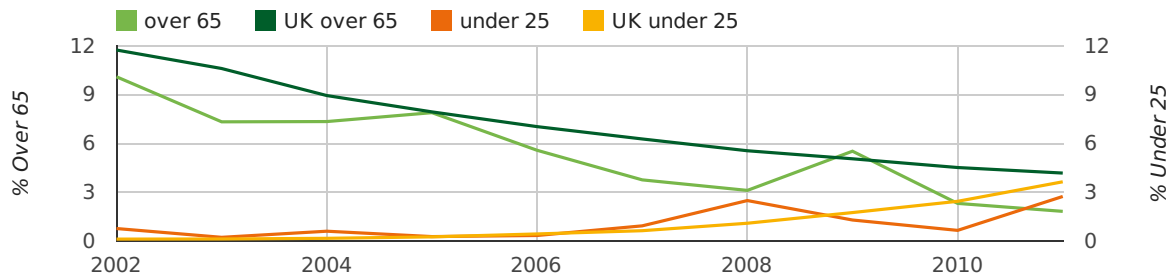

#### director age by year



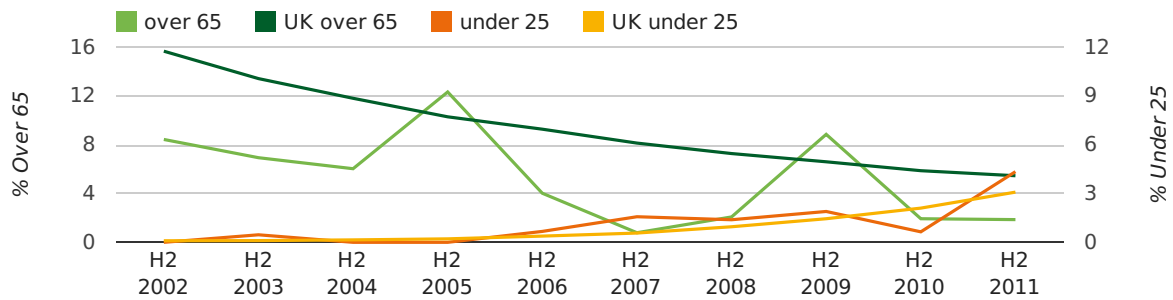
### Half Year Data (Jul-Dec 2011)

#### director age by half year



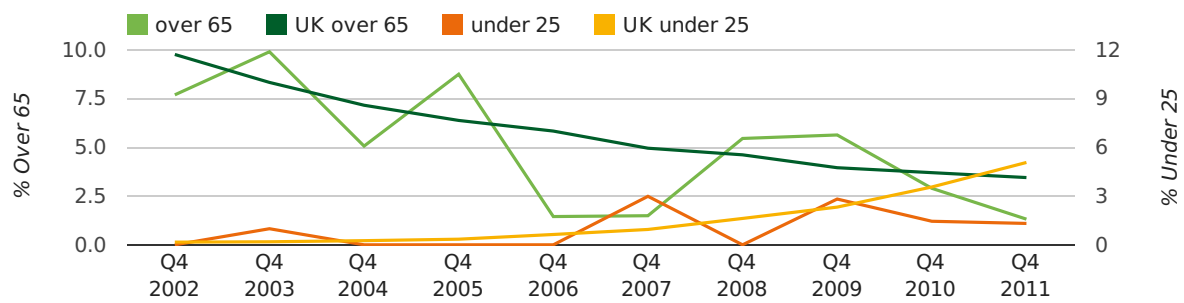

### director age by quarter

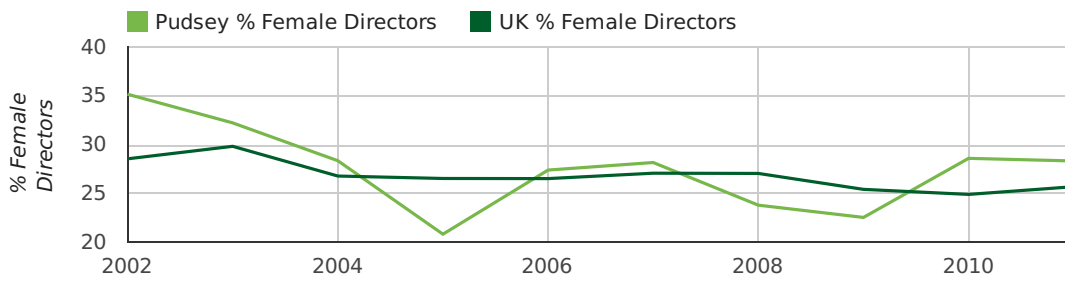


### Annual Data (2011)

#### director gender by year

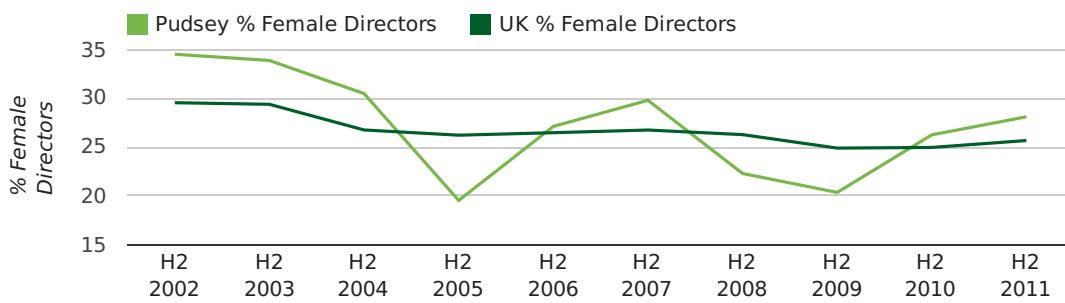


### Half Year Data (Jul-Dec 2011)

#### director gender by half year

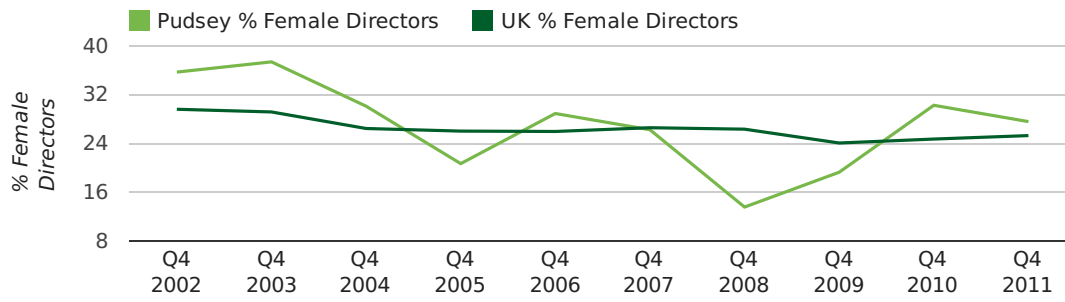


## Quarterly Data (Q4 Oct-Dec 2011)

The record fourth quarter for female directors in Pudsey was in 1977 when 31.1% of all directors were female.
