

new companies by year




Half Year Data (Jul-Dec 2011)

new companies by half year




A total of 30 companies were registered in Pulborough during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 18 companies were dissolved in Pulborough during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 36 companies were added to the company register for Pulborough in 2011. This number represents growth of 35.6% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year










company share by half year





director age by year





director age by half year




director age by quarter

director gender by year



director gender by half year


