

2011 was a record year for company registrations in Purley when compared to any year in history.

A total of 223 companies were formed in Purley in 2011. This total is 14.4% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Purley when compared to any previous second half year.

In the second half of 2011 a total of 117 companies were formed in Purley. This figure is 25.8% higher than last year, which compares well to the UK wide figure of 14.0%.

#### new companies by half year




A total of 55 companies were registered in Purley during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### new companies by quarter



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 74 companies were dissolved in Purley. This figure is 80.5% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Purley occurred in 2009 when a total of 86 were closed.

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Purley when compared to any previous Q4.

A total of 44 companies were dissolved in Purley during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 120.0% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.


#### dissolved companies by quarter


A total of 78 companies were added to the company register for Purley in 2011. This number represents growth of 40.0% which compares favourably to the UK figure of 34.6%.




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Purley during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 11 companies.

This represents a decrease of 62.1% on the same period last year.








#### company share by half year





#### director age by year




## Half Year Data (Jul-Dec 2011)

#### director age by half year




The average age of a director in the fourth quarter of 2011 was 40.1.

#### director gender by year




# Half Year Data (Jul-Dec 2011)

#### director gender by half year


