
The first half of 2012 saw a new record in company registrations in Purley when compared to any previous first half year.

In the first half of 2012 a total of 137 companies were formed in Purley. This figure is 29.2% higher than last year, which compares well to the UK wide figure of 10.7%.

Q2 2012 saw a new record in company registrations in Purley when compared to any previous Q2.


Q2 2012 was a record quarter for company registrations in Purley when compared to any quarter in history.



#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2012)






Q2 2012 saw a new record in net growth in Purley when compared to any previous Q2.

Net company growth for Purley during the second quarter of 2012 (Apr 2012 - Jun 2012) was 37 companies.






company share by half year





### director age by half year




## Quarterly Data (Q2 Apr-Jun 2012)

The percentage of directors over the age of 65 was 4.2% compared to the UK figure of 3.3%.




## director age by quarter

#### director gender by half year




# Quarterly Data (Q2 Apr-Jun 2012)
