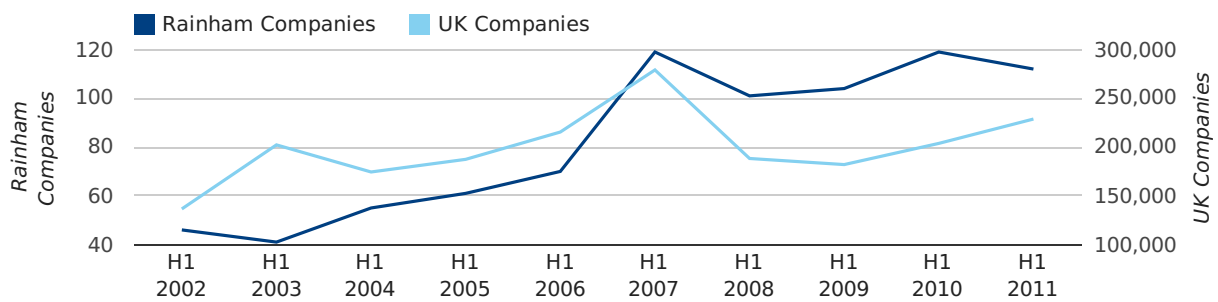
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 112 companies were formed in Rainham. This figure is 5.9% lower than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Rainham occurred in 2007 when a total of 119 were formed.

new companies by half year



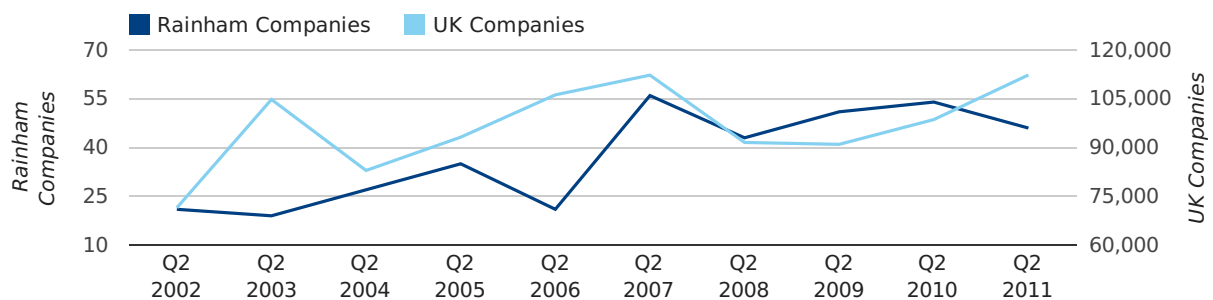
Quarterly Data (Q2 Apr-Jun 2011)

A total of 46 companies were registered in Rainham during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is a decrease of 14.8% versus the same period last year (Q2 2010). This figure compares badly to the UK as a whole, which saw an increase of 13.9% against the same period last year.

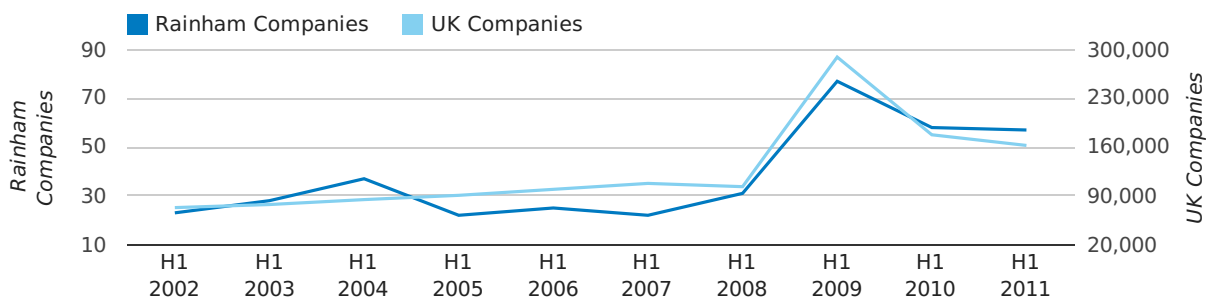
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 57 companies were dissolved in Rainham. This figure is 1.7% lower than last year, which compares badly to the UK wide change of -8.6%.

The highest total for a first half year in Rainham occurred in 2009 when a total of 77 were closed.

dissolved companies by half year



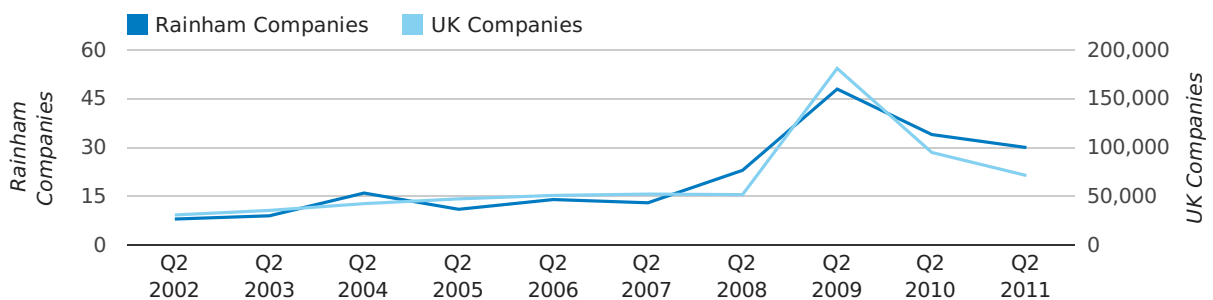
Quarterly Data (Q2 Apr-Jun 2011)

This figure is a decrease of 11.8% versus the same period last year (Q2 2010). This figure compares poorly to the UK as a whole, which saw a decrease of 24.9% against the same period last year.

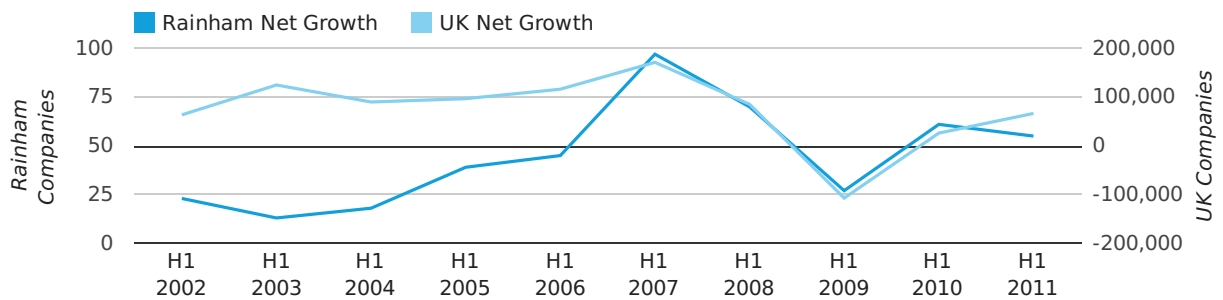

net growth by half year



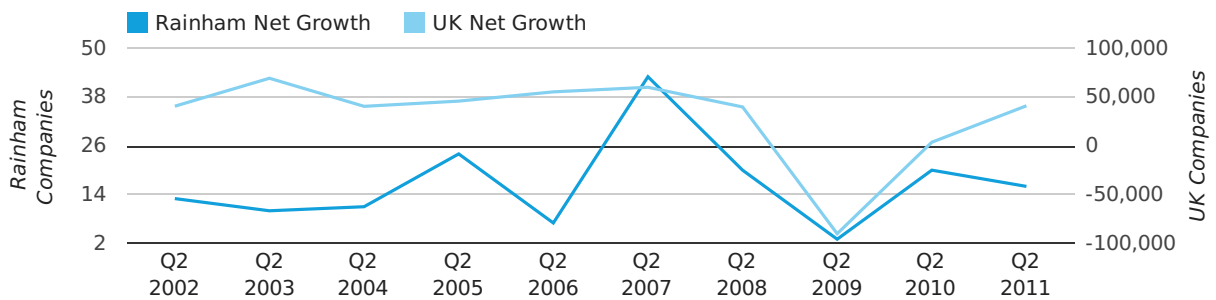
Quarterly Data (Q2 Apr-Jun 2011)

This represents a decrease of 20.0% on the same period last year.

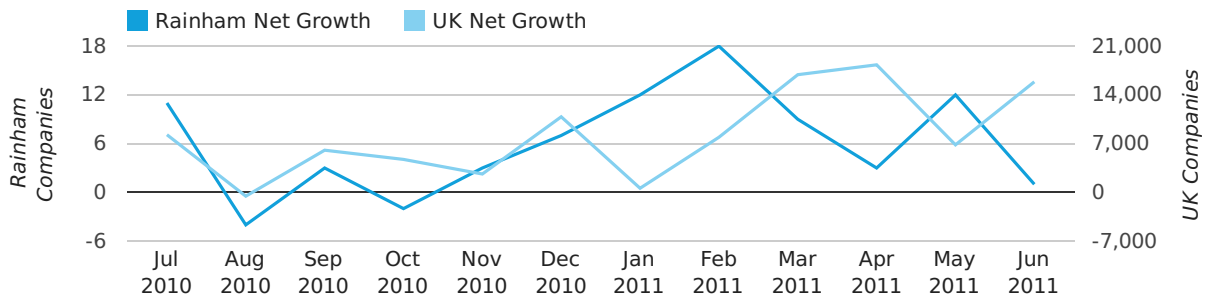

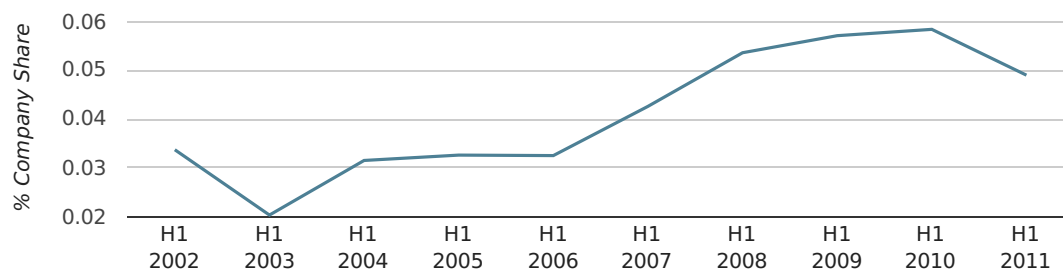

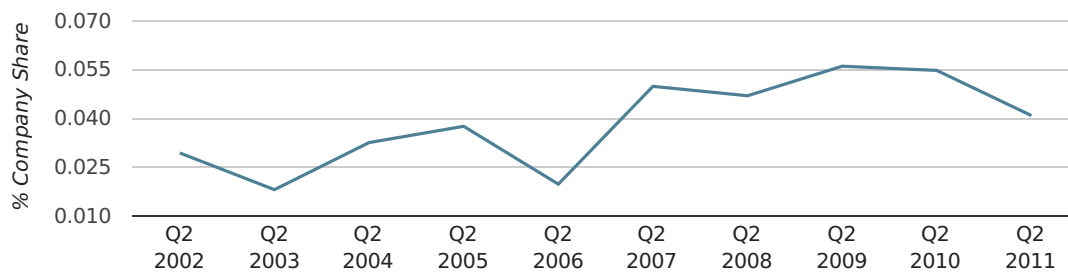

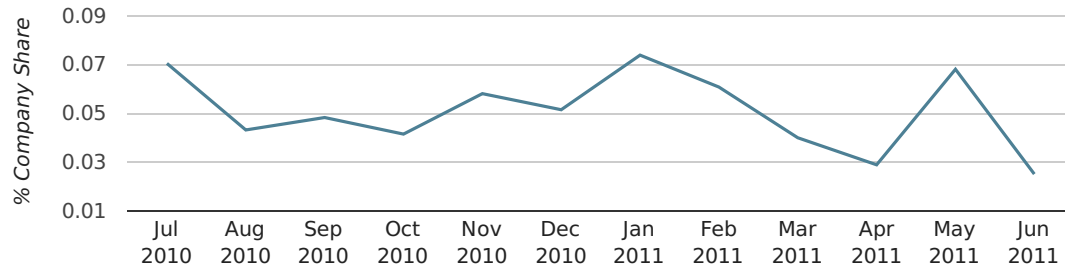

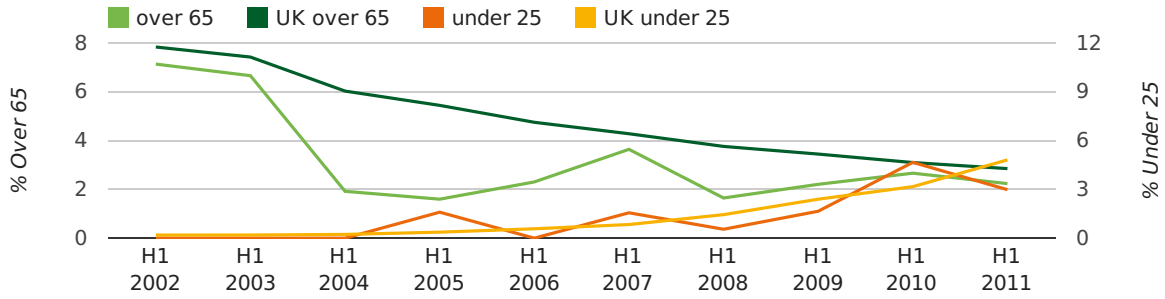

director age by half year



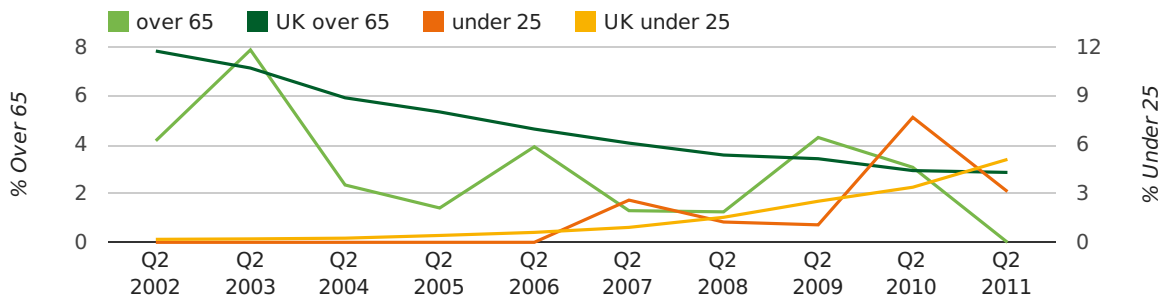
Quarterly Data (Q2 Apr-Jun 2011)

director age by quarter

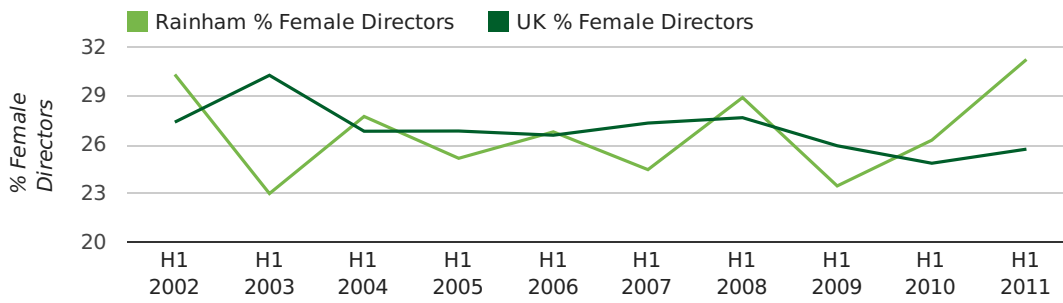


Half Year Data (Jan-Jun 2011)

31.3% of all director appointments in Rainham in the first half of 2011 were female. This compares to a UK average of 25.7% for the same period.

director gender by half year

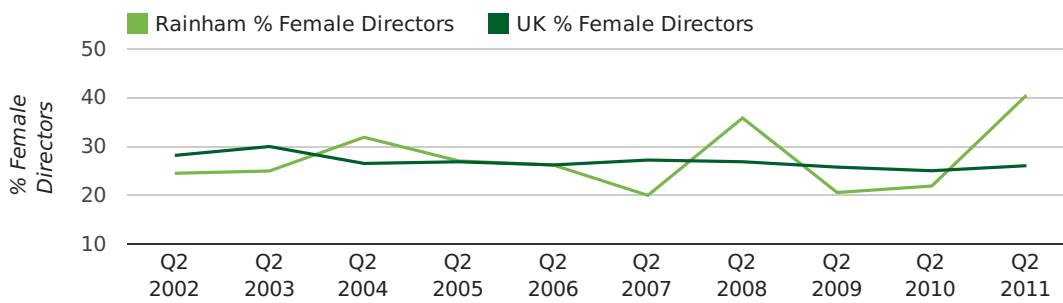


Quarterly Data (Q2 Apr-Jun 2011)
