

The second half of 2011 saw a new record in company registrations in Rainham when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Rainham when compared to any half year in history.

Q4 2011 saw a new record in company registrations in Rainham when compared to any previous Q4.


Q4 2011 was a record quarter for company registrations in Rainham when compared to any quarter in history.

new companies by quarter





new companies by month



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Rainham when compared to any previous Q4.




A total of 120 companies were added to the company register for Rainham in 2011. This number represents growth of 54.1% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Rainham during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 32 companies.


net growth by quarter

net growth by month



company share by year




company share by half year








director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


