
The first half of 2012 saw a new record in company registrations in Rainham when compared to any previous first half year.


Q2 2012 saw a new record in company registrations in Rainham when compared to any previous Q2.


new companies by quarter



dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)



net growth by half year















director age by half year




