




# Quarterly Data (Q2 Apr-Jun 2012)

#### dissolved companies by half year





A total of 35 companies were dissolved in Ramsgate during the second quarter of 2012 (Apr 2012 - Jun 2012).













#### director age by half year




#### Quarterly Data (Q2 Apr-Jun 2012)

The percentage of directors over the age of 65 was 0.0% compared to the UK figure of 3.3%.




#### director age by quarter

#### director gender by half year




# Quarterly Data (Q2 Apr-Jun 2012)
