

In the first half of 2011 a total of 1,618 companies were formed in Reading. This figure is 7.2% higher than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Reading occurred in 2005 when a total of 2,874 were formed.

#### new companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)

A total of 779 companies were registered in Reading during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is an increase of 4.1% versus the same period last year (Q2 2010). This figure compares badly to the UK as a whole, which saw an increase of 13.9% against the same period last year.



#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)

A total of 866 companies were dissolved in Reading during the second quarter of 2011 (Apr 2011 - Jun 2011).





#### net growth by half year















#### director age by half year




