




## Quarterly Data (Q2 Apr-Jun 2012)

A total of 769 companies were registered in Reading during the second quarter of 2012 (Apr 2012 - Jun 2012).





#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)

A total of 701 companies were dissolved in Reading during the second quarter of 2012 (Apr 2012 - Jun 2012).









company share by half year





company share by month





#### director age by half year




