

A total of 228 companies were formed in Redcar in 2011. This total is 21.3% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

## Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company registrations in Redcar when compared to any previous second half year.

In the second half of 2011 a total of 114 companies were formed in Redcar. This figure is 56.2% higher than last year, which compares well to the UK wide figure of 14.0%.

#### new companies by half year




A total of 45 companies were registered in Redcar during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





## dissolved companies by half year




A total of 26 companies were dissolved in Redcar during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 99 companies were added to the company register for Redcar in 2011. This number represents growth of 52.7% which compares favourably to the UK figure of 34.6%.




#### Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Redcar during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 19 companies.


#### net growth by quarter

#### net growth by month






company share by year







#### director age by year




#### director age by half year

#### director gender by year




# Half Year Data (Jul-Dec 2011)
