




A total of 54 companies were registered in Redcar during the second quarter of 2012 (Apr 2012 - Jun 2012).






## Quarterly Data (Q2 Apr-Jun 2012)

A total of 26 companies were dissolved in Redcar during the second quarter of 2012 (Apr 2012 - Jun 2012).



#### dissolved companies by quarter








Net company growth for Redcar during the second quarter of 2012 (Apr 2012 - Jun 2012) was 28 companies.

#### net growth by quarter






company share by half year





#### director age by half year




#### Quarterly Data (Q2 Apr-Jun 2012)

The percentage of directors over the age of 65 was 0.0% compared to the UK figure of 3.3%.




#### director age by quarter
