
The first half of 2011 saw a new record in company registrations in Redhill when compared to any previous first half year.

Q2 2011 saw a new record in company registrations in Redhill when compared to any previous Q2.


Q2 2011 was a record quarter for company registrations in Redhill when compared to any quarter in history.



A total of 55 companies were dissolved in Redhill during the second quarter of 2011 (Apr 2011 - Jun 2011).







Net company growth for Redhill during the second quarter of 2011 (Apr 2011 - Jun 2011) was 53 companies.






company share by half year





director age by half year



director gender by half year


