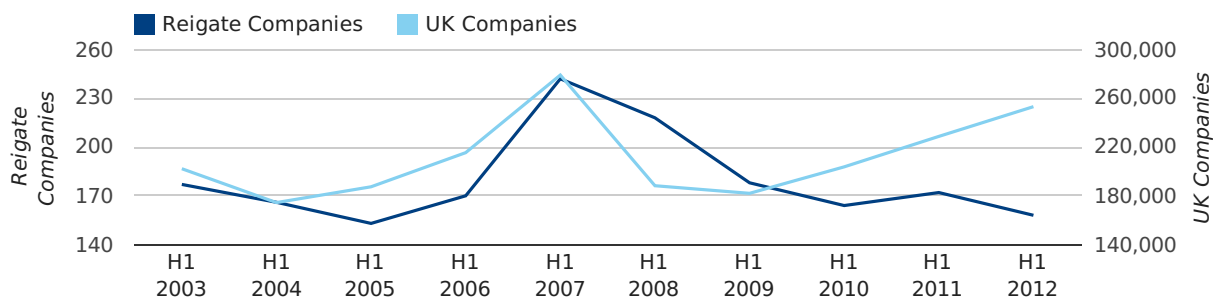
### Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 158 companies were formed in Reigate. This figure is 8.1% lower than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Reigate occurred in 2007 when a total of 242 were formed.

### new companies by half year



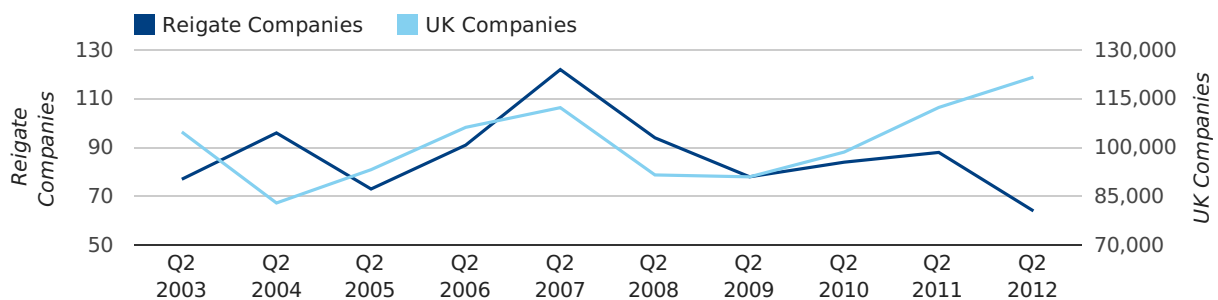
### Quarterly Data (Q2 Apr-Jun 2012)

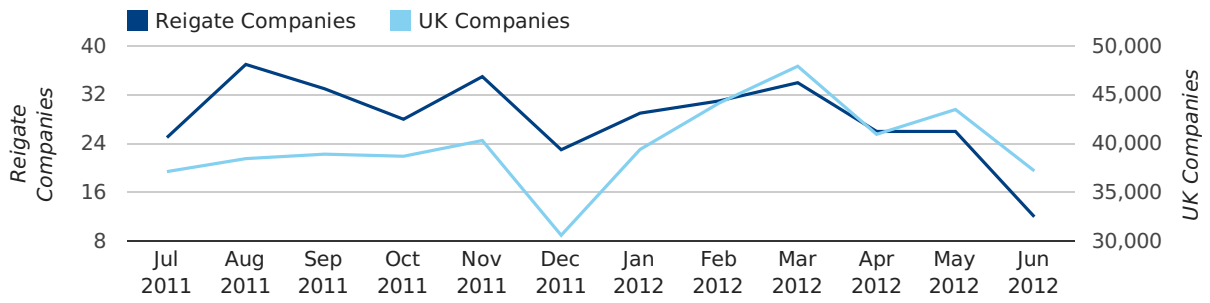

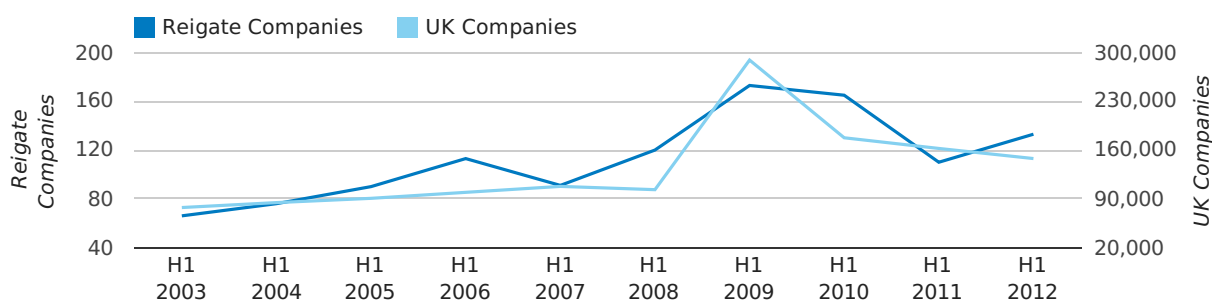
### Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 133 companies were dissolved in Reigate. This figure is 20.9% higher than last year, which compares badly to the UK wide change of -8.9%.

The highest total for a first half year in Reigate occurred in 2009 when a total of 173 were closed.

### dissolved companies by half year



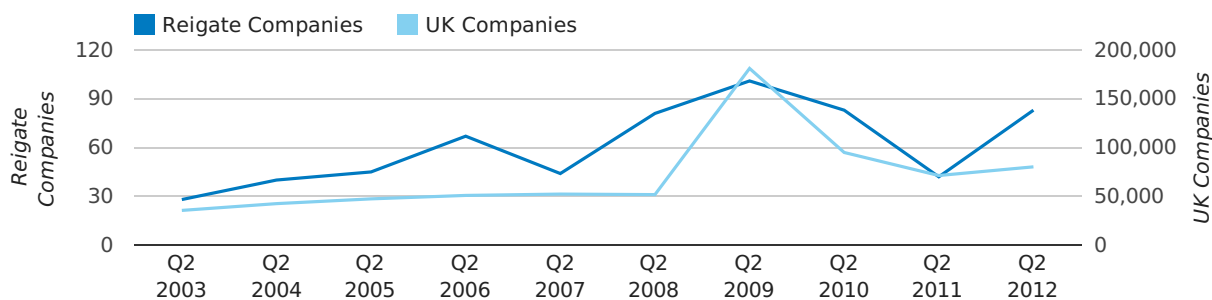
### Quarterly Data (Q2 Apr-Jun 2012)

This figure is an increase of 97.6% versus the same period last year (Q2 2011). This figure compares poorly to the UK as a whole, which saw an increase of 12.5% against the same period last year.

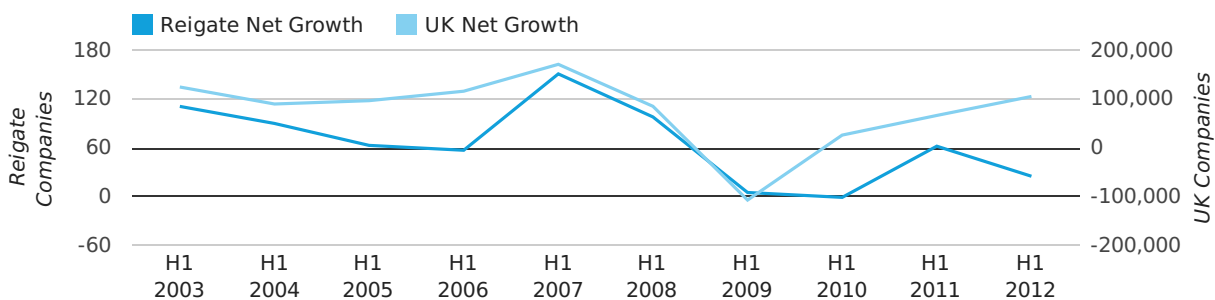

### net growth by half year



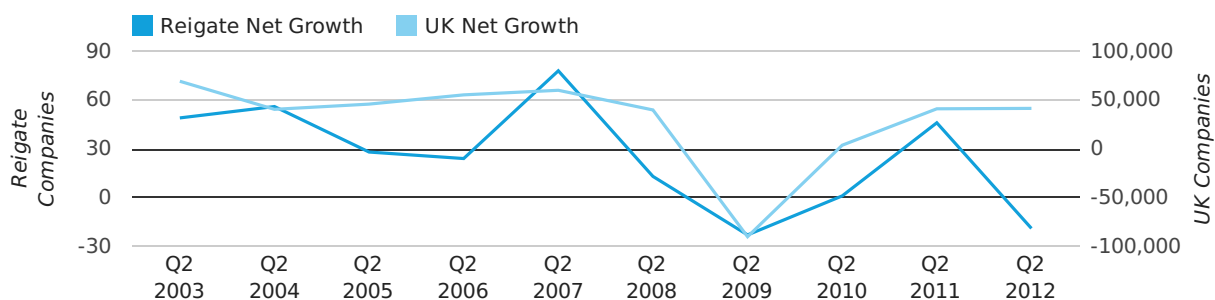
### Quarterly Data (Q2 Apr-Jun 2012)

This represents a decrease of 141.3% on the same period last year.

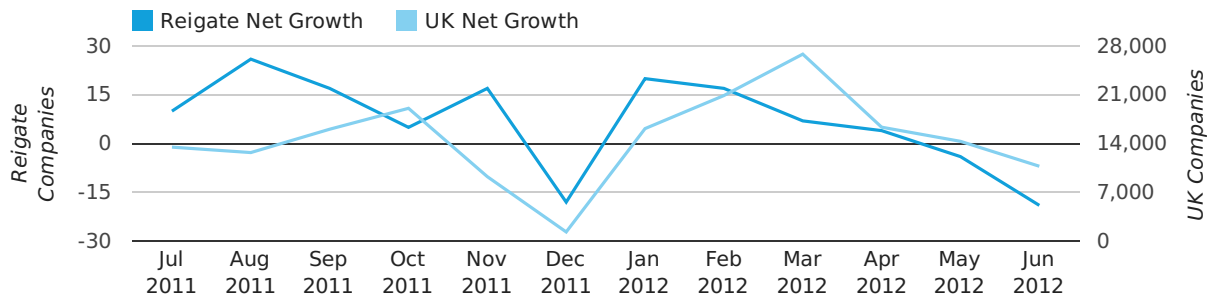

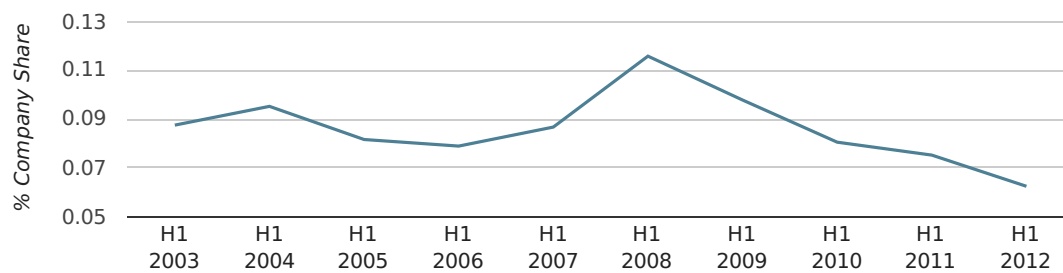

### company share by half year

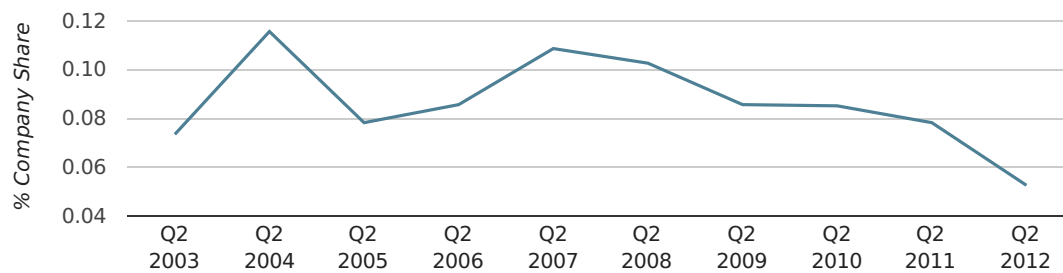

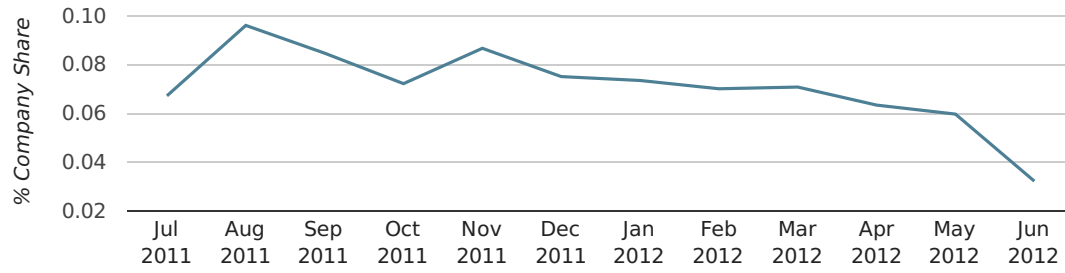

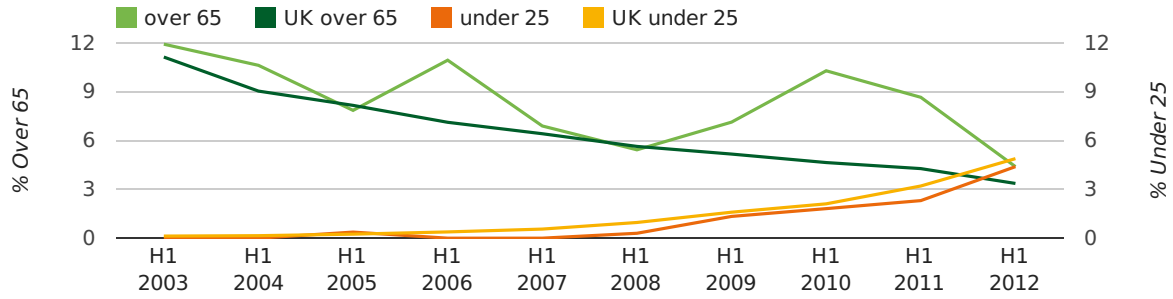
### Half Year Data (Jan-Jun 2012)

#### director age by half year



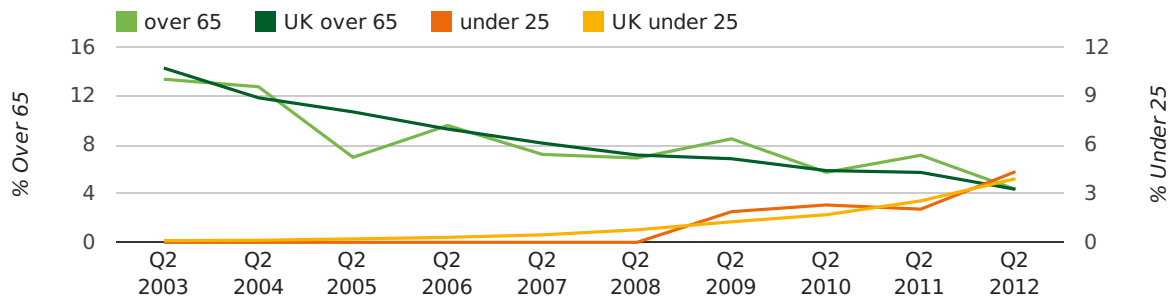
### Quarterly Data (Q2 Apr-Jun 2012)

#### director age by quarter

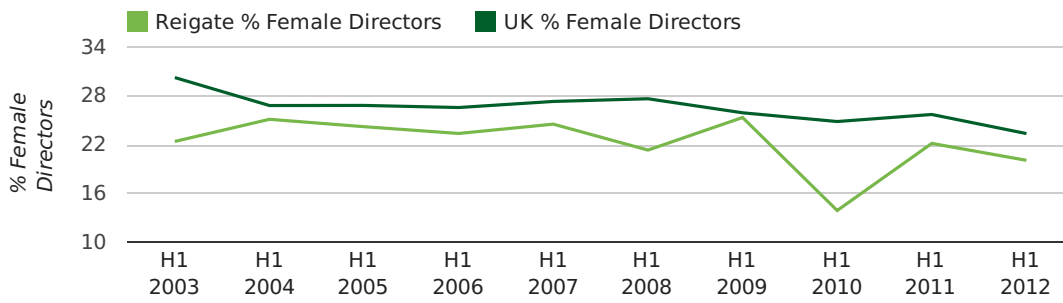


### Half Year Data (Jan-Jun 2012)

20.1% of all director appointments in Reigate in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

#### director gender by half year

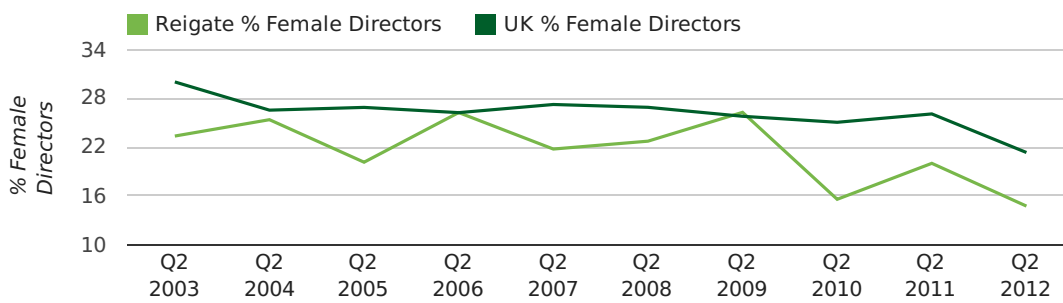


### Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Reigate was in 1866 when 66.7% of all directors were female.

14.7% of all director appointments in Reigate in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
