




Half Year Data (Jul-Dec 2011)




new companies by half year



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 31 companies were dissolved in Retford during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 37 companies were added to the company register for Retford in 2011. This number represents growth of 21.6% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year



net growth by quarter






company share by year



company share by half year





director age by year





director age by quarter





director gender by year




Half Year Data (Jul-Dec 2011)
