• November 2011 saw a new record in company closures in Rickmansworth when compared to any previous November.



new companies by year




Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 209 companies were formed in Rickmansworth. This figure is 3.0% higher than last year, which compares badly to the UK wide figure of 14.0%.

new companies by half year




A total of 95 companies were registered in Rickmansworth during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 83 companies were dissolved in Rickmansworth during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter



net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Rickmansworth during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 12 companies.








company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


