


In the first half of 2012 a total of 100 companies were formed in Ringwood. This figure is 0.0% the same as last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Ringwood occurred in 2007 when a total of 106 were formed.

#### new companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)





#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)

A total of 35 companies were dissolved in Ringwood during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 52.2% versus the same period last year (Q2 2011). This figure compares poorly to the UK as a whole, which saw an increase of 12.5% against the same period last year.



#### net growth by half year













#### director age by half year




## Quarterly Data (Q2 Apr-Jun 2012)

The percentage of directors over the age of 65 was 1.4% compared to the UK figure of 3.3%.


#### director age by quarter

#### director gender by half year




# Quarterly Data (Q2 Apr-Jun 2012)
