
Q3 2011 saw a new record in company registrations in Rochester when compared to any previous Q3.

A total of 132 companies were registered in Rochester during the third quarter of 2011 (Jul 2011 - Sep 2011).

This figure is an increase of 24.5% versus the same period last year (Q3 2010). This figure compares well to the UK as a whole, which saw an increase of 12.8% against the same period last year.

August 2011 saw a new record in company registrations in Rochester when compared to any previous August.




#### new companies by month



dissolved companies by month





net growth by quarter









The percentage of directors over the age of 65 was 4.5% compared to the UK figure of 4.1%.


#### director age by quarter
