

A total of 513 companies were formed in Rochester in 2011. This total is 21.3% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

## Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company registrations in Rochester when compared to any previous second half year.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Rochester when compared to any previous Q4.





dissolved companies by year




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 190 companies were dissolved in Rochester. This figure is 9.2% higher than last year, which compares badly to the UK wide change of -7.5%.

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Rochester when compared to any previous Q4.

A total of 110 companies were dissolved in Rochester during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 39.2% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.


A total of 152 companies were added to the company register for Rochester in 2011. This number represents growth of 35.9% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Rochester during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 29 companies.

#### net growth by quarter






company share by year




company share by half year





#### director age by year






The percentage of directors over the age of 65 was 2.3% compared to the UK figure of 4.1%.





#### director gender by year




## Half Year Data (Jul-Dec 2011)

27.0% of all director appointments in Rochester in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


#### director gender by half year
