

A total of 1,136 companies were formed in Romford in 2011. This total is 12.4% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

## Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company registrations in Romford when compared to any previous second half year.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Romford when compared to any previous Q4.



November 2011 saw a new record in company registrations in Romford when compared to any previous November.





# Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 323 companies were dissolved in Romford. This figure is 21.6% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Romford occurred in 2009 when a total of 520 were closed.


A total of 480 companies were added to the company register for Romford in 2011. This number represents growth of 47.5% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)




Net company growth for Romford during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 85 companies.


company share by year







#### director age by year



The percentage of directors over the age of 65 was 3.0% compared to the UK figure of 4.1%.




The average age of a director in the fourth quarter of 2011 was 39.4.

#### director gender by year




## Half Year Data (Jul-Dec 2011)

The record second half year for female directors in Romford was 1860 when 42.9% of all directors were female.

27.1% of all director appointments in Romford in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.
