

#### new companies by year




## Half Year Data (Jul-Dec 2011)

The second half of 2011 saw a new record in company registrations in Romsey when compared to any previous second half year.

In the second half of 2011 a total of 136 companies were formed in Romsey. This figure is 52.8% higher than last year, which compares well to the UK wide figure of 14.0%.



dissolved companies by year




## Half Year Data (Jul-Dec 2011)

### dissolved companies by half year




A total of 33 companies were dissolved in Romsey during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 111 companies were added to the company register for Romsey in 2011. This number represents growth of 47.6% which compares favourably to the UK figure of 34.6%.

#### net growth by year




## Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Romsey during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 29 companies.

#### net growth by quarter






company share by year





The percentage of directors over the age of 65 was 9.8% compared to the UK figure of 4.1%.



#### director gender by year




## Half Year Data (Jul-Dec 2011)
