

2011 was a record year for company registrations in Rotherham when compared to any year in history.

A total of 727 companies were formed in Rotherham in 2011. This total is 19.6% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Rotherham when compared to any previous second half year.

In the second half of 2011 a total of 330 companies were formed in Rotherham. This figure is 8.6% higher than last year, which compares badly to the UK wide figure of 14.0%.




A total of 143 companies were registered in Rotherham during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


new companies by quarter



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Rotherham when compared to any previous Q4.


dissolved companies by quarter


A total of 289 companies were added to the company register for Rotherham in 2011. This number represents growth of 47.5% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Rotherham during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 31 companies.








company share by half year





director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)
