

In the first half of 2012 a total of 367 companies were formed in Rotherham. This figure is 7.6% lower than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Rotherham occurred in 2011 when a total of 397 were formed.

Q2 2012 saw a new record in company registrations in Rotherham when compared to any previous Q2.

A total of 180 companies were registered in Rotherham during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 1.1% versus the same period last year (Q2 2011). This figure compares badly to the UK as a whole, which saw an increase of 8.3% against the same period last year.


Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 195 companies were dissolved in Rotherham. This figure is 5.8% lower than last year, which compares badly to the UK wide change of -8.9%.

The highest total for a first half year in Rotherham occurred in 2009 when a total of 364 were closed.

A total of 94 companies were dissolved in Rotherham during the second quarter of 2012 (Apr 2012 - Jun 2012).












company share by half year





director age by half year



The percentage of directors under the age of 25 was 6.3% compared to the UK figure of 5.2%.


The percentage of directors over the age of 65 was 3.2% compared to the UK figure of 3.3%.

director gender by half year




Quarterly Data (Q2 Apr-Jun 2012)
