


In the first half of 2012 a total of 313 companies were formed in Rugby. This figure is 6.8% lower than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Rugby occurred in 2010 when a total of 361 were formed.

new companies by half year




Quarterly Data (Q2 Apr-Jun 2012)

A total of 147 companies were registered in Rugby during the second quarter of 2012 (Apr 2012 - Jun 2012).





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)

This figure is an increase of 45.5% versus the same period last year (Q2 2011). This figure compares poorly to the UK as a whole, which saw an increase of 12.5% against the same period last year.



net growth by half year





Net company growth for Rugby during the second quarter of 2012 (Apr 2012 - Jun 2012) was 19 companies.











director age by half year





The percentage of directors over the age of 65 was 4.2% compared to the UK figure of 3.3%.


director age by quarter

director gender by half year


