

A total of 752 companies were formed in Salford in 2011. This total is 21.5% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Salford when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Salford when compared to any half year in history.

Q4 2011 saw a new record in company registrations in Salford when compared to any previous Q4.


Q4 2011 was a record quarter for company registrations in Salford when compared to any quarter in history.

new companies by quarter





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Salford when compared to any previous Q4.




A total of 345 companies were added to the company register for Salford in 2011. This number represents growth of 55.7% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Salford during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 95 companies.


net growth by quarter

net growth by month






company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

21.3% of all director appointments in Salford in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
