

#### new companies by half year




Q4 2011 saw a new record in company registrations in Sandbach when compared to any previous Q4.





#### dissolved companies by year




## Half Year Data (Jul-Dec 2011)

# dissolved companies by half year




A total of 19 companies were dissolved in Sandbach during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 69 companies were added to the company register for Sandbach in 2011. This number represents growth of 38.8% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Q4 2011 saw a new record in net growth in Sandbach when compared to any previous Q4.



#### net growth by month











#### director age by year





#### director age by half year




## director age by quarter

#### director gender by year




# Half Year Data (Jul-Dec 2011)

#### director gender by half year


