


The second half of 2011 saw a new record in company registrations in Sandy when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Sandy when compared to any previous Q4.





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 21 companies were dissolved in Sandy during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 47 companies were added to the company register for Sandy in 2011. This number represents growth of 39.2% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Sandy during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 15 companies.








company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


