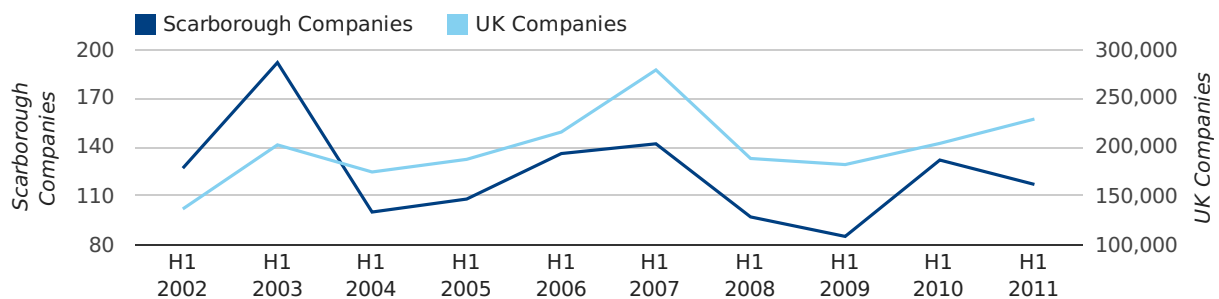
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 117 companies were formed in Scarborough. This figure is 11.4% lower than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Scarborough occurred in 2003 when a total of 192 were formed.

new companies by half year



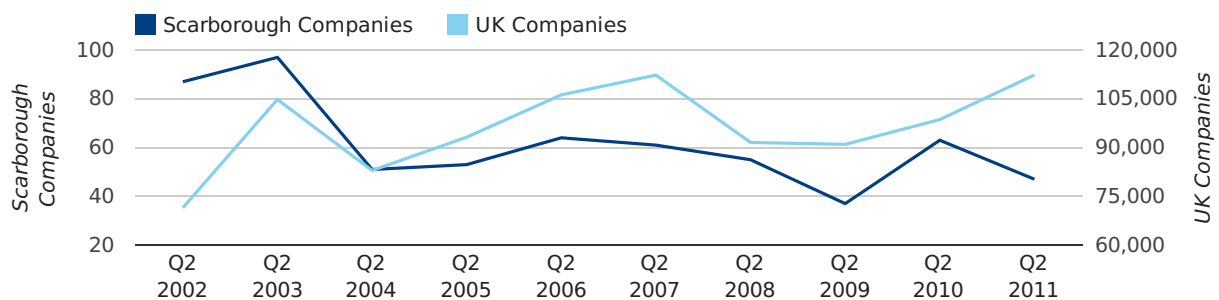
Quarterly Data (Q2 Apr-Jun 2011)

A total of 47 companies were registered in Scarborough during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is a decrease of 25.4% versus the same period last year (Q2 2010). This figure compares badly to the UK as a whole, which saw an increase of 13.9% against the same period last year.

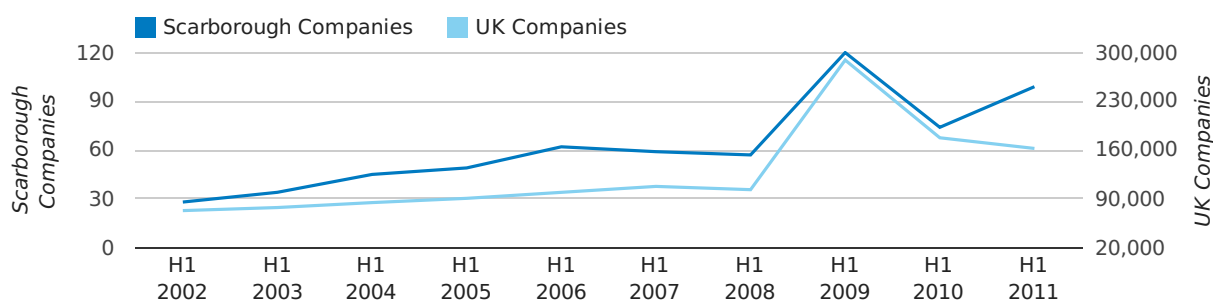
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 99 companies were dissolved in Scarborough. This figure is 33.8% higher than last year, which compares badly to the UK wide change of -8.6%.

The highest total for a first half year in Scarborough occurred in 2009 when a total of 120 were closed.

dissolved companies by half year



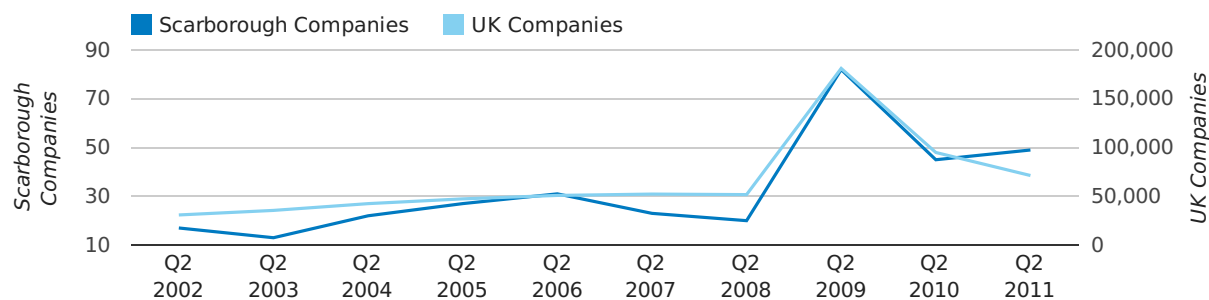
Quarterly Data (Q2 Apr-Jun 2011)

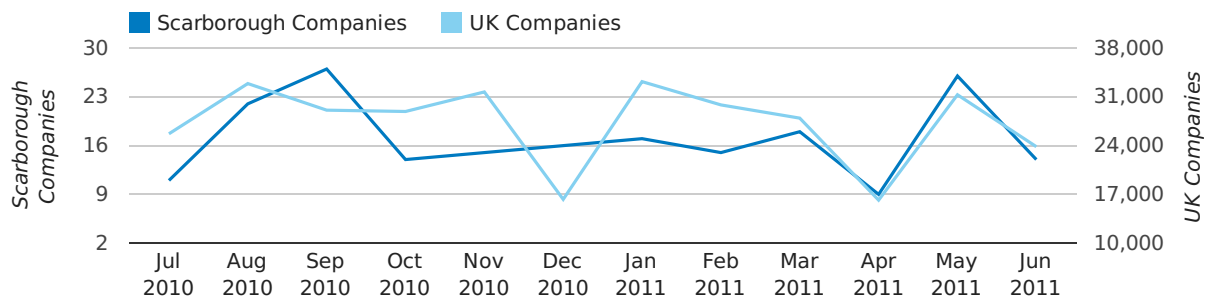

dissolved companies by month



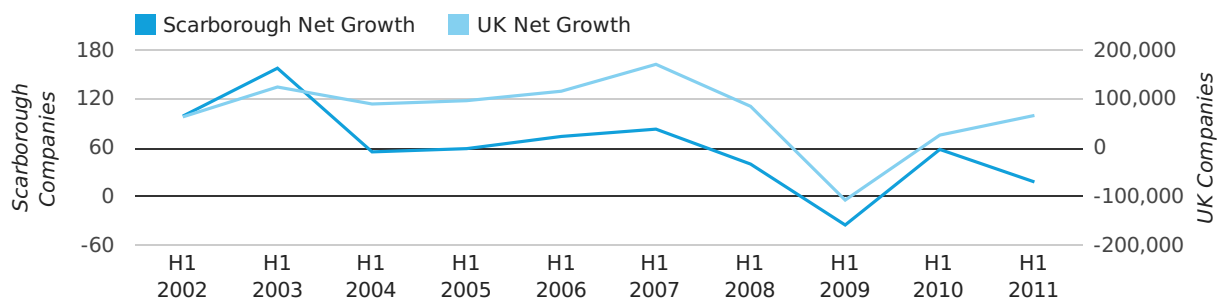

net growth by half year



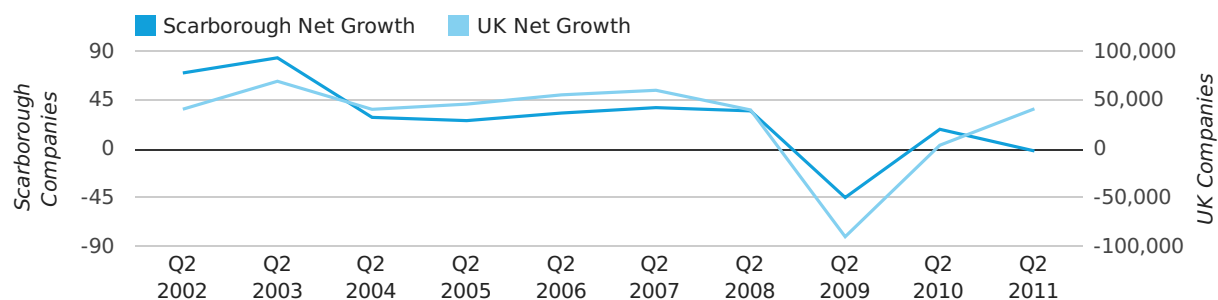

This represents a decrease of 111.1% on the same period last year.

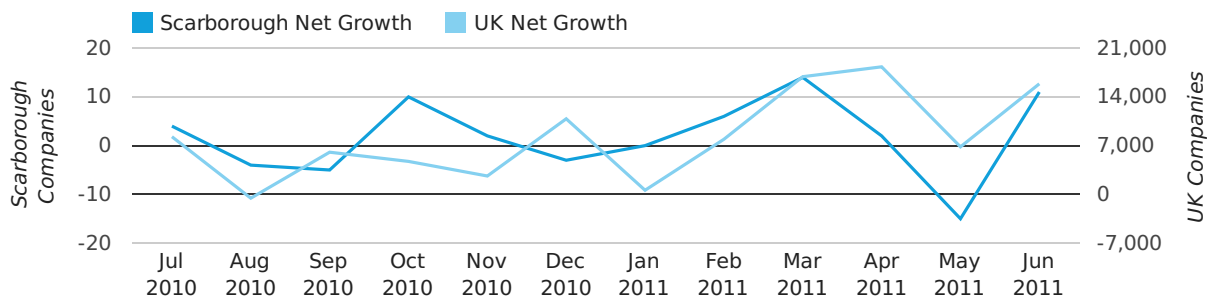

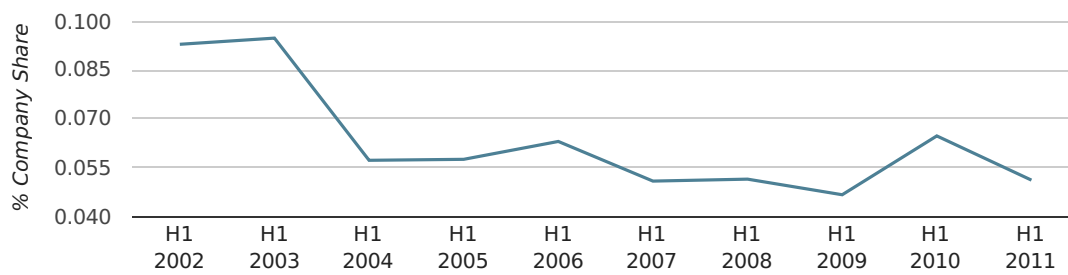

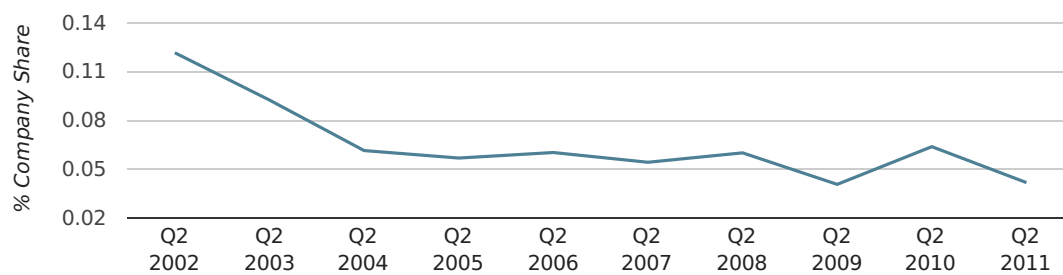

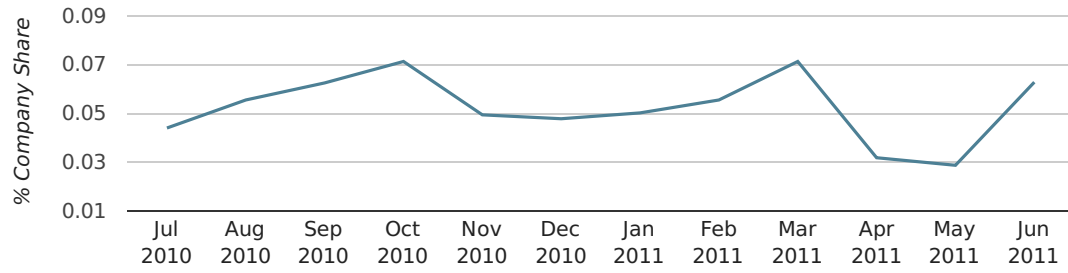

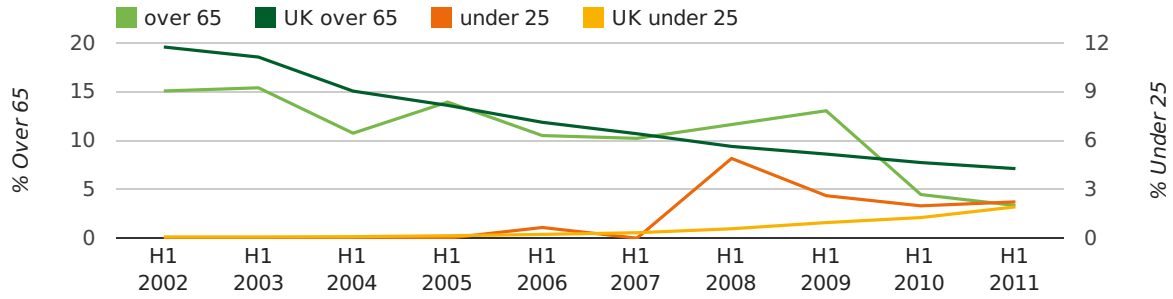

director age by half year



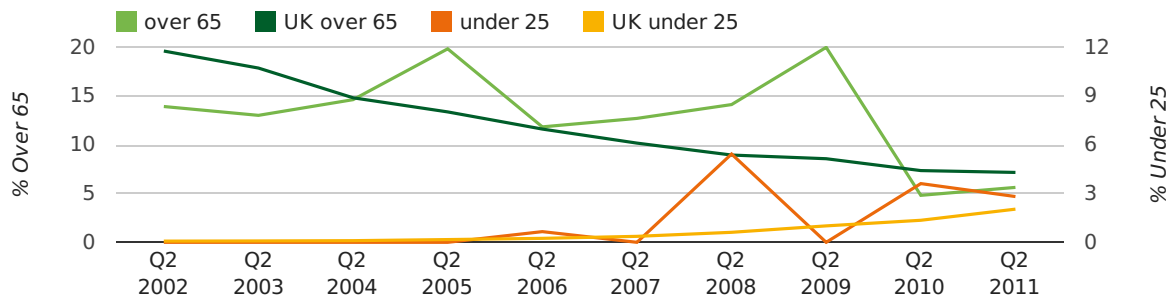

director age by quarter

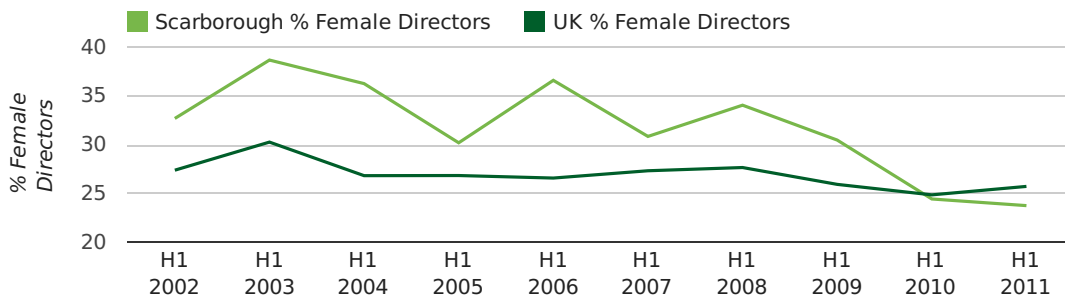


Half Year Data (Jan-Jun 2011)

director gender by half year

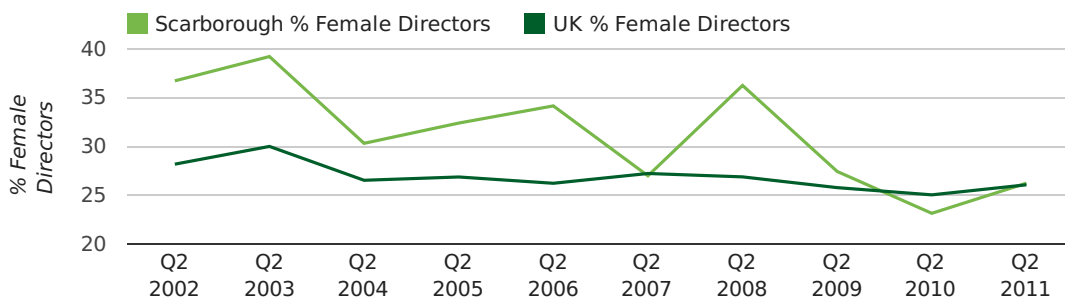


Quarterly Data (Q2 Apr-Jun 2011)

The record second quarter for female directors in Scarborough was in 1866 when 66.7% of all directors were female.
