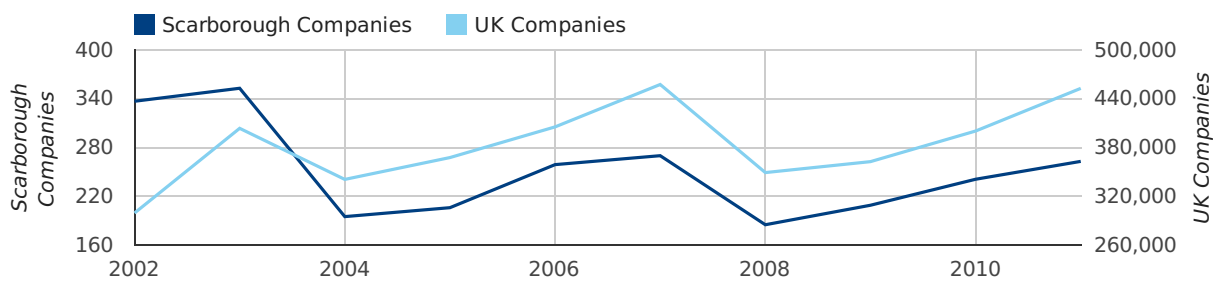

### Annual Data (2011)

A total of 263 companies were formed in Scarborough in 2011. This total is 9.1% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

### new companies by year



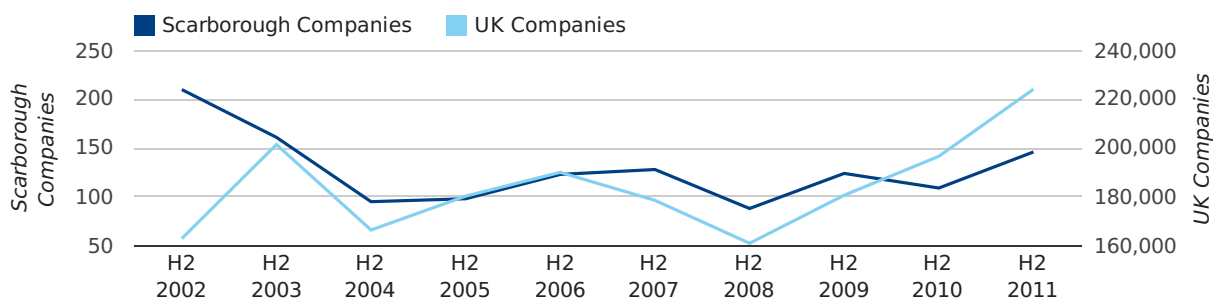
### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 146 companies were formed in Scarborough. This figure is 33.9% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Scarborough occurred in 2002 when a total of 210 were formed.

### new companies by half year



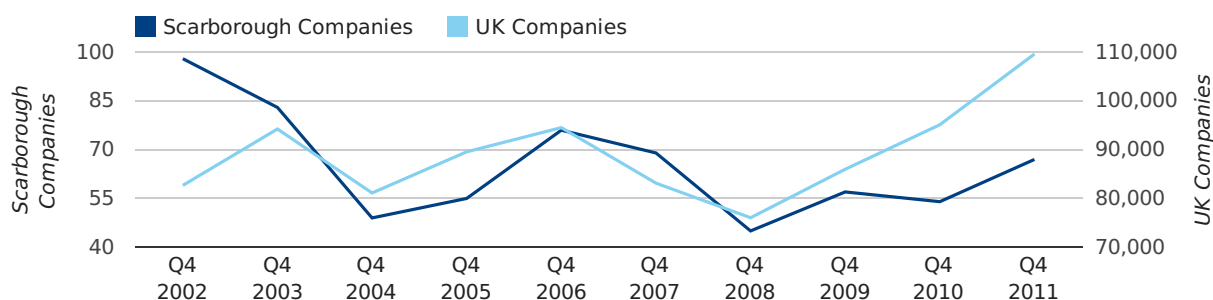
## Quarterly Data (Q4 Oct-Dec 2011)

### dissolved companies by year



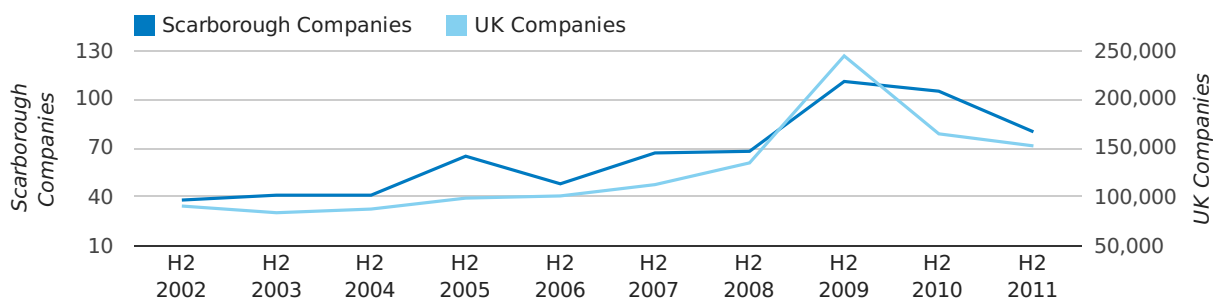
### Half Year Data (Jul-Dec 2011)

### dissolved companies by half year



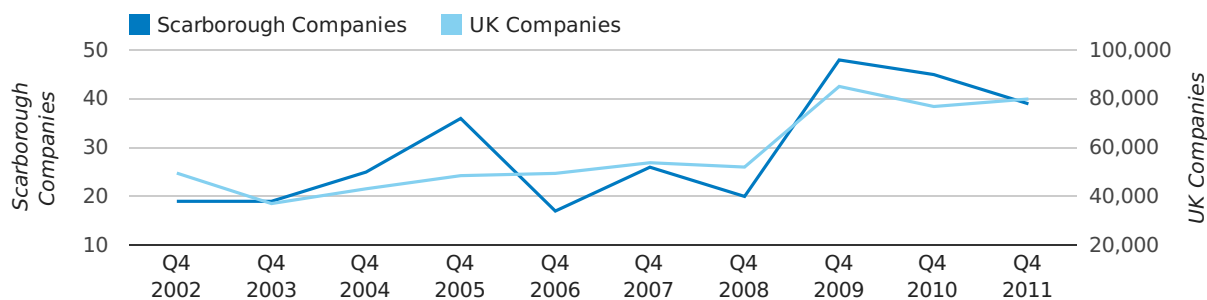
## Quarterly Data (Q4 Oct-Dec 2011)

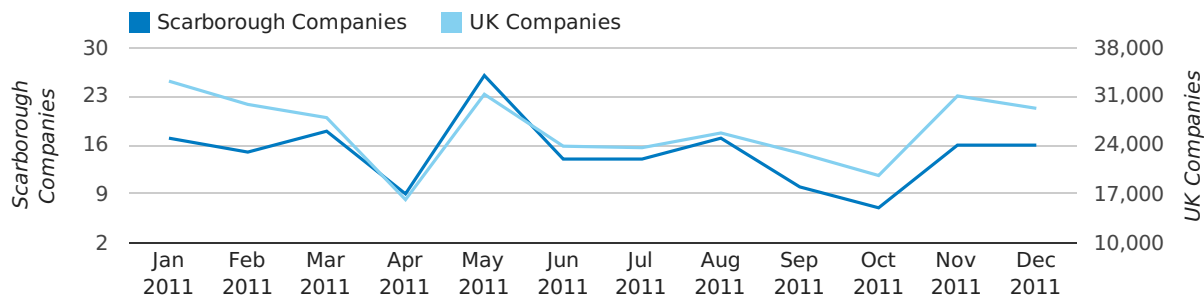

### Annual Data (2011)

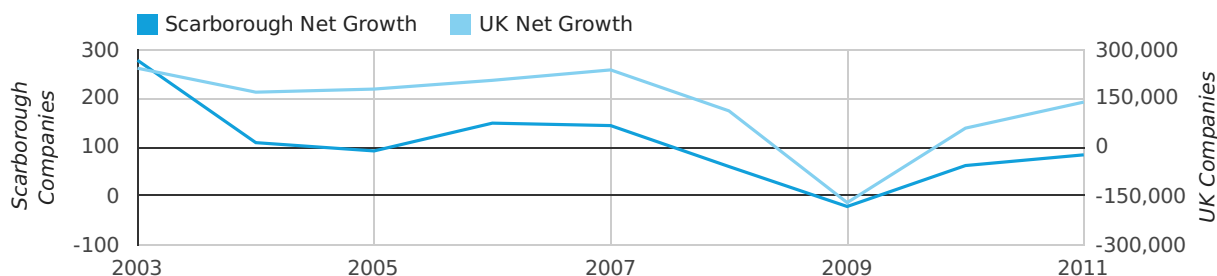
A total of 84 companies were added to the company register for Scarborough in 2011. This number represents growth of 34.9% which compares favourably to the UK figure of 34.6%.

### net growth by year

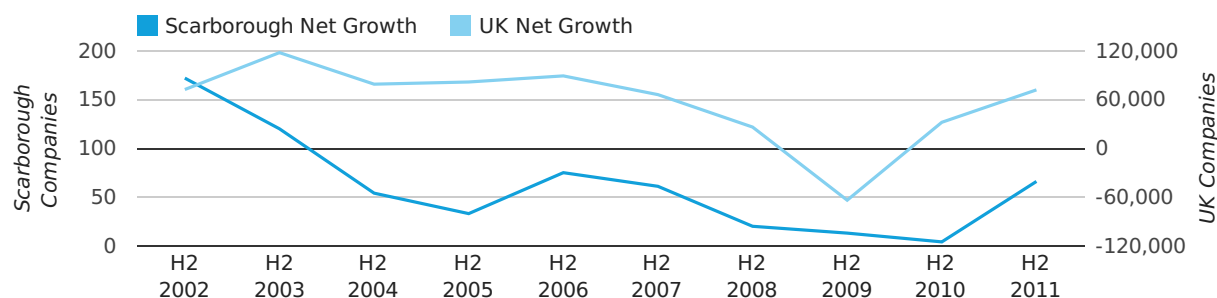


### Half Year Data (Jul-Dec 2011)

### net growth by half year



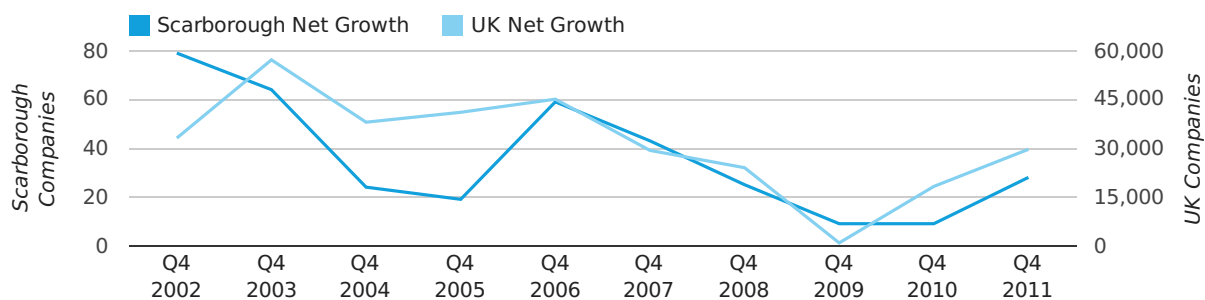

This represents an increase of 211.1% on the same period last year.

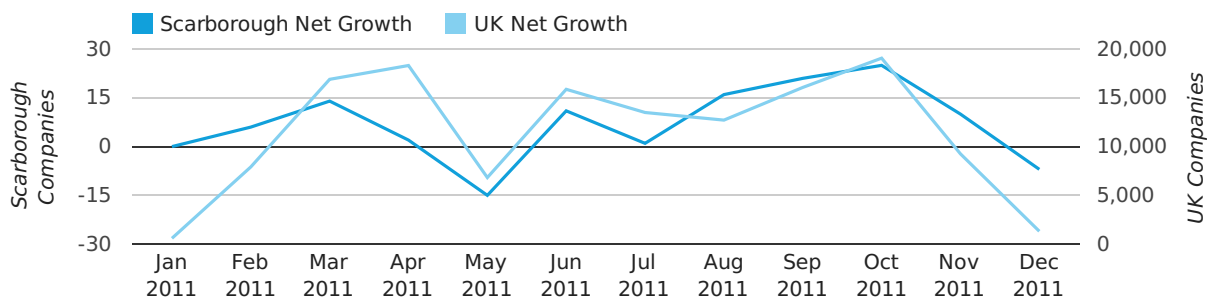

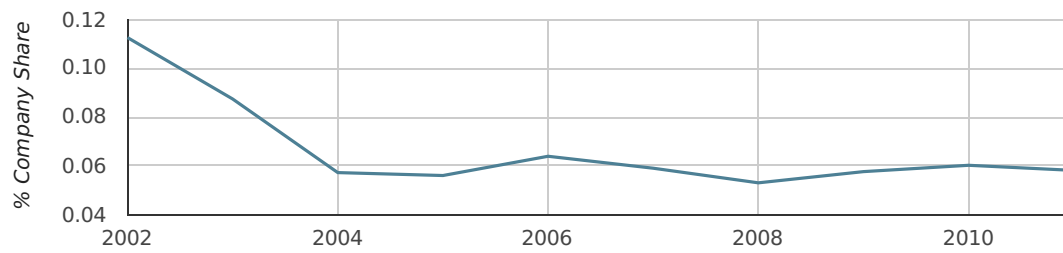

#### company share by year

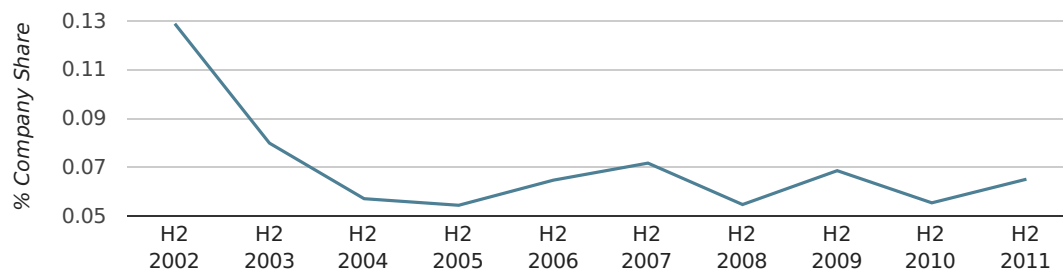

#### company share by half year

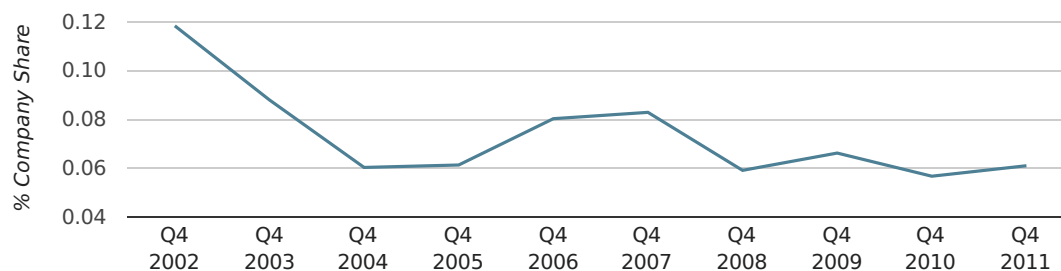

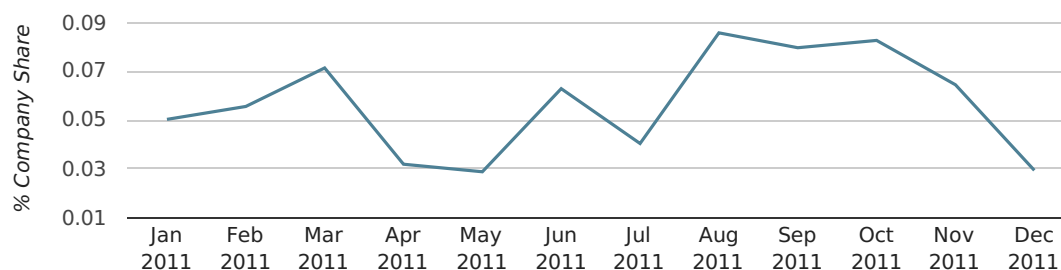

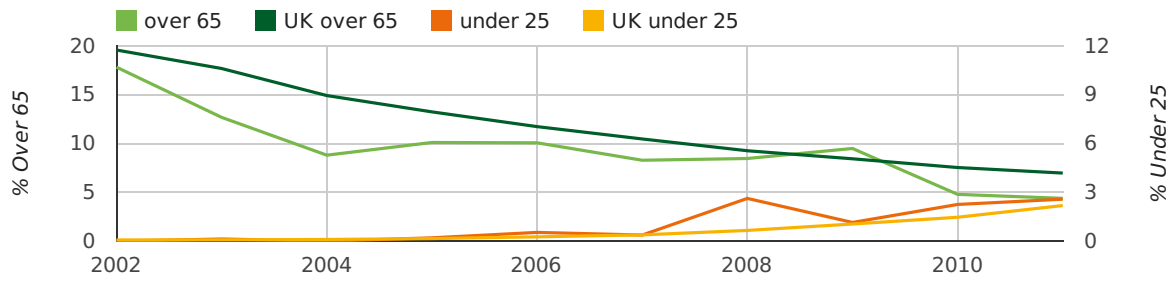

#### director age by year



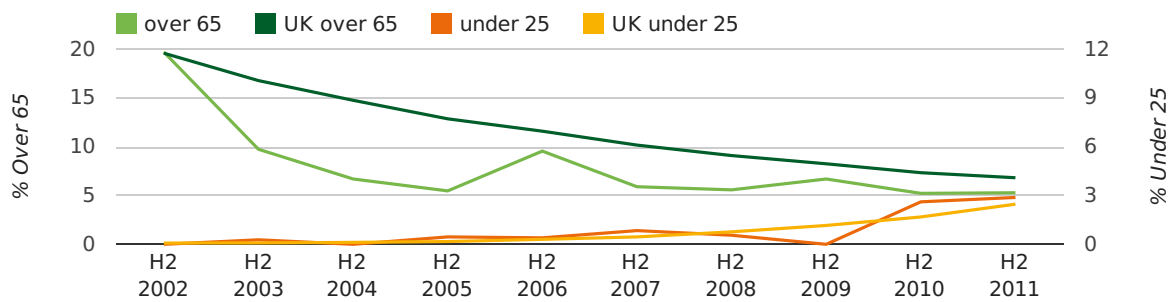
### Half Year Data (Jul-Dec 2011)

#### director age by half year



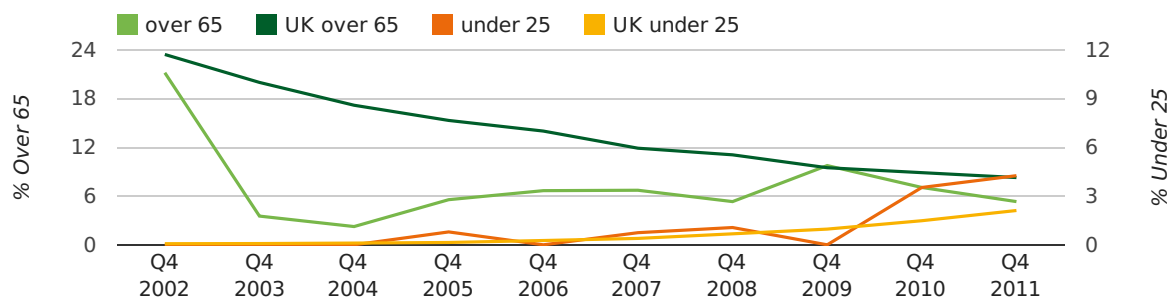

### director age by quarter

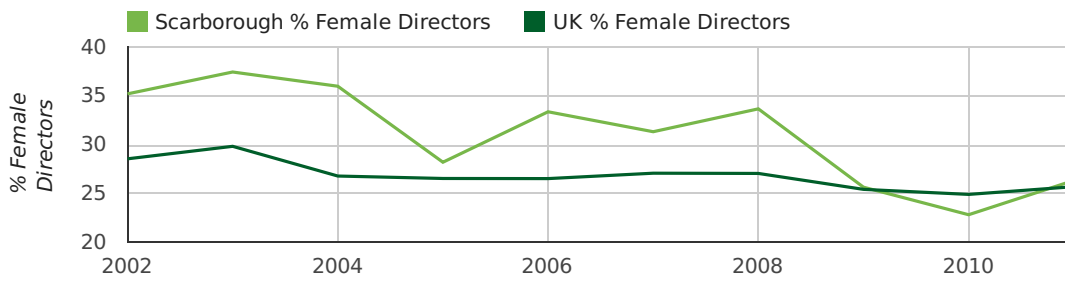


### Annual Data (2011)

#### director gender by year

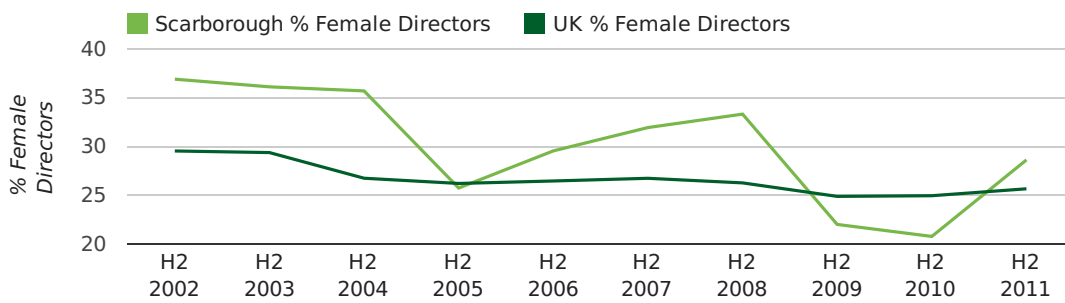


### Half Year Data (Jul-Dec 2011)

#### director gender by half year

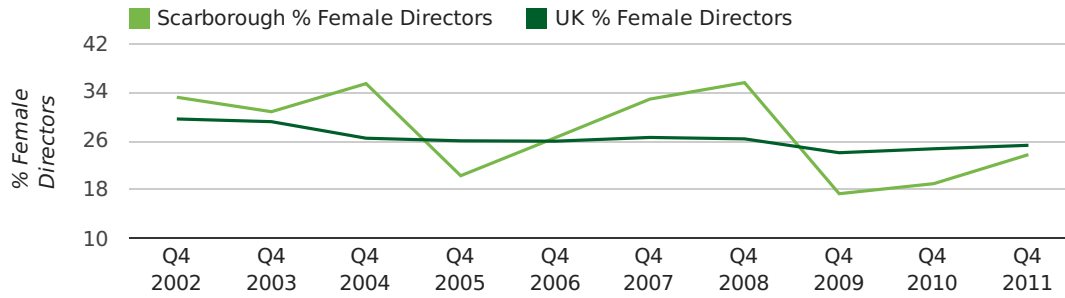


## Quarterly Data (Q4 Oct-Dec 2011)

The record fourth quarter for female directors in Scarborough was in 1977 when 31.1% of all directors were female.
