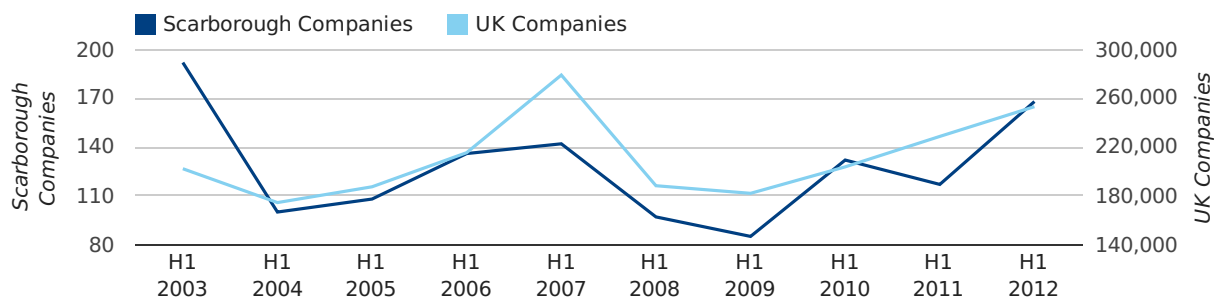
### Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 168 companies were formed in Scarborough. This figure is 43.6% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Scarborough occurred in 2003 when a total of 192 were formed.

### new companies by half year



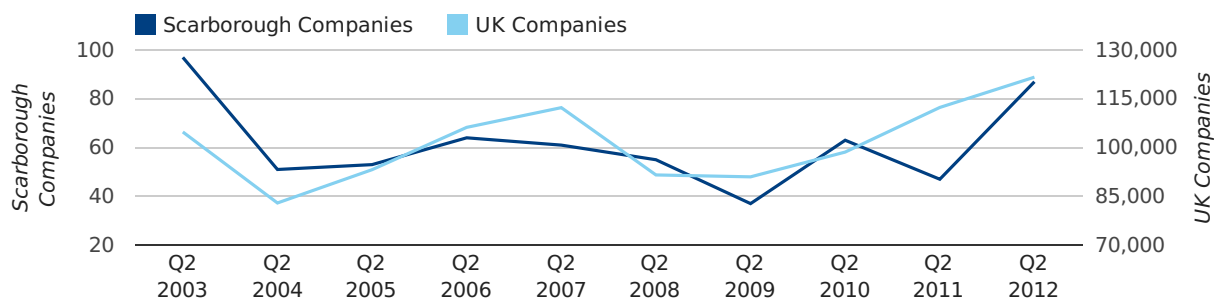
### Quarterly Data (Q2 Apr-Jun 2012)

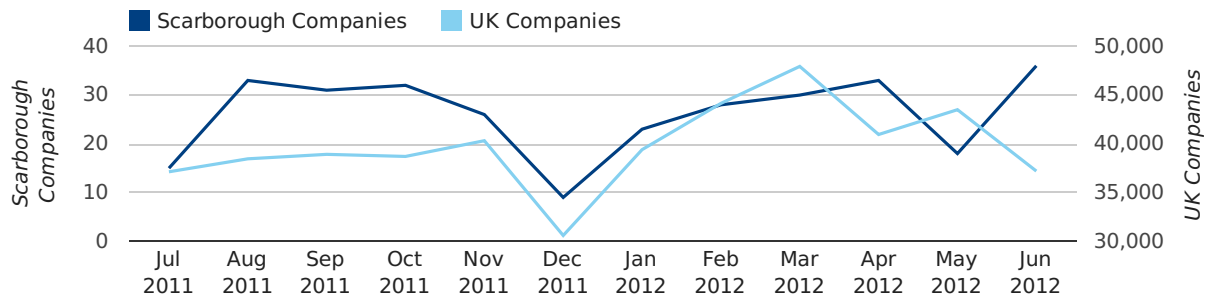

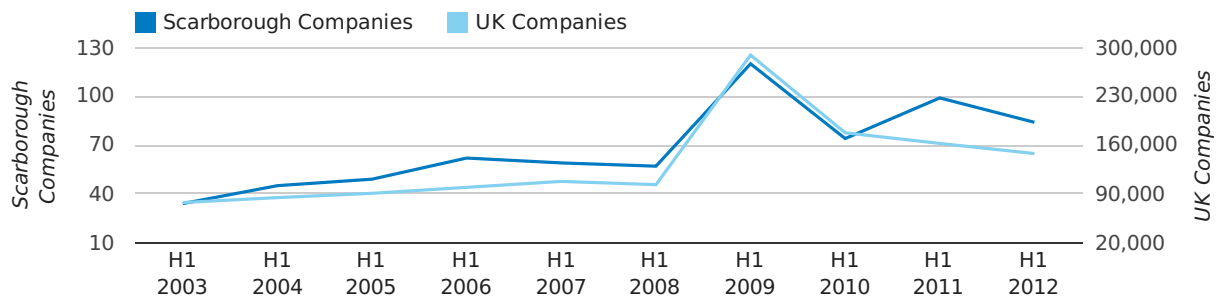
### Half Year Data (Jan-Jun 2012)

### dissolved companies by half year



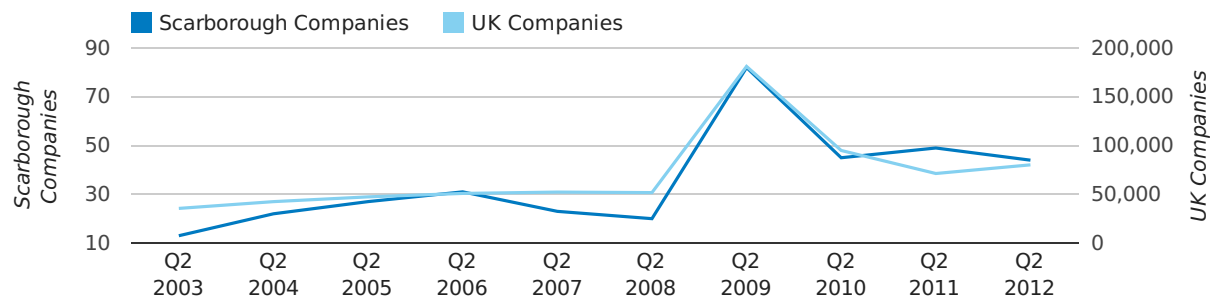
### Quarterly Data (Q2 Apr-Jun 2012)

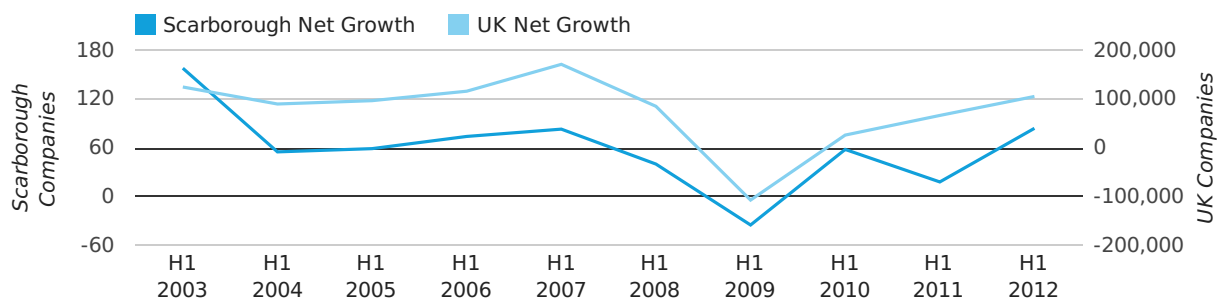

### net growth by half year



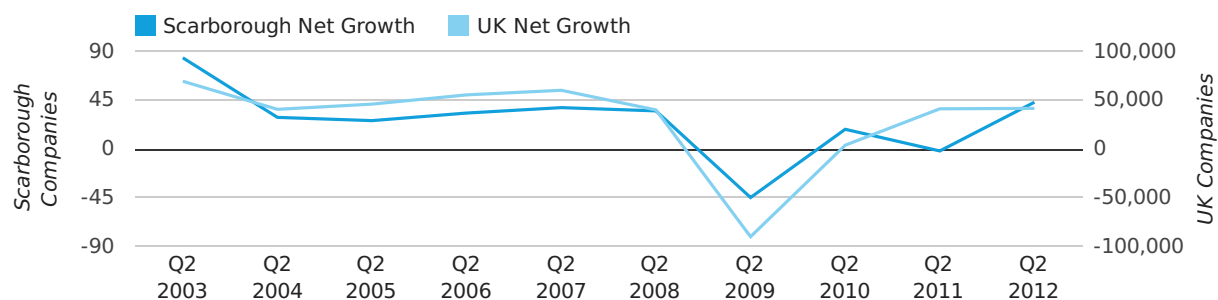

This represents an increase of 2,250.0% on the same period last year.

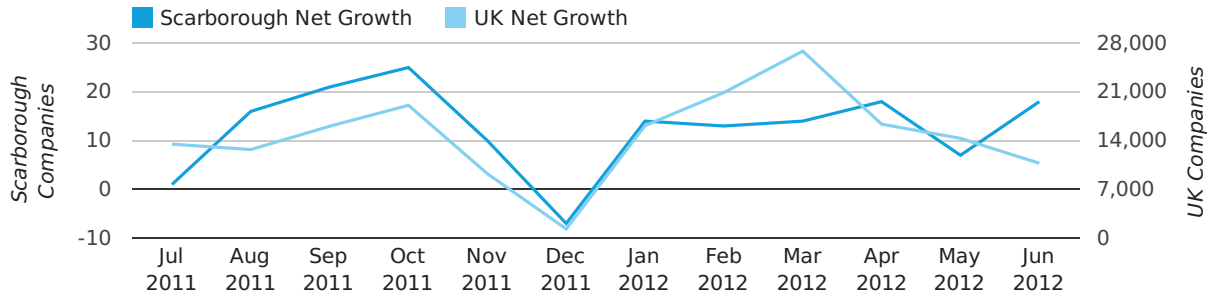

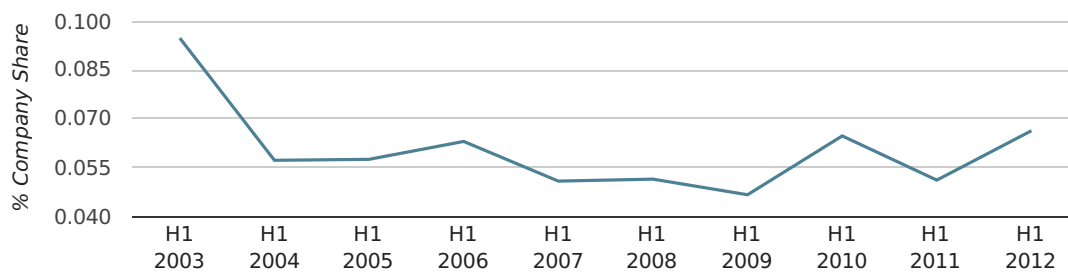

#### company share by half year

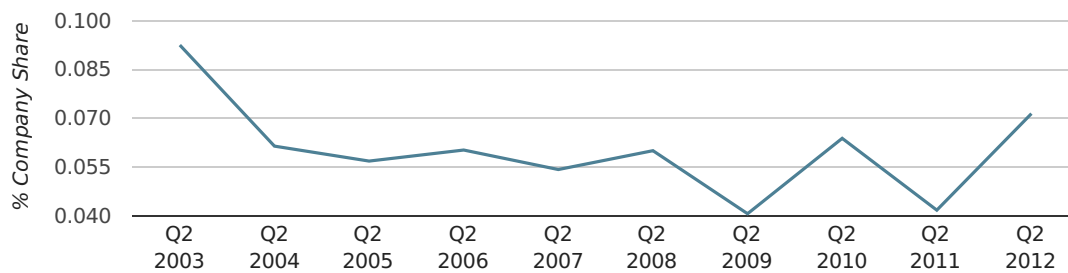

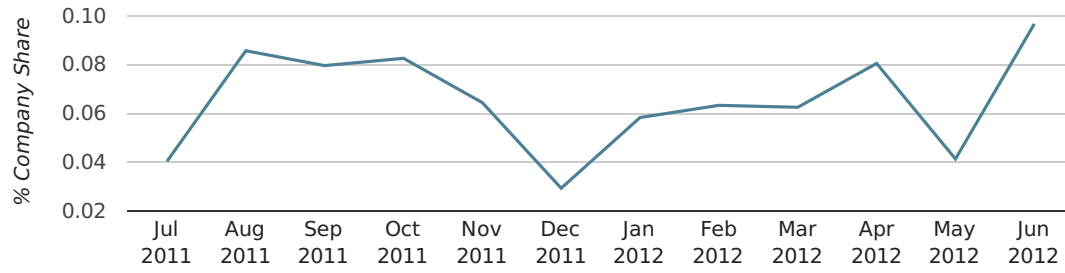

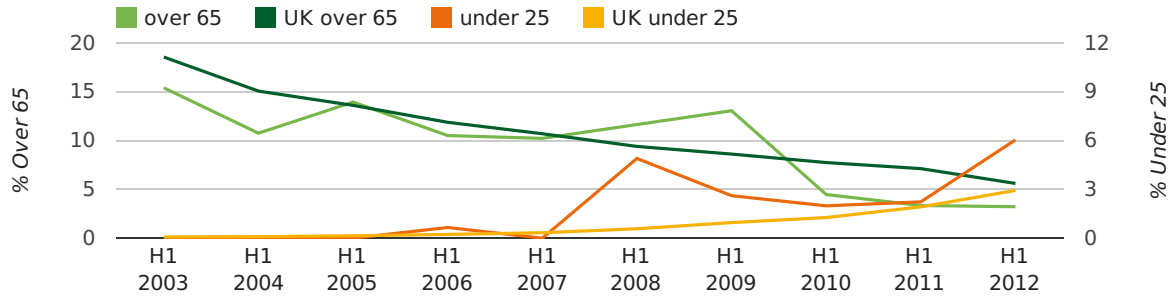
### Half Year Data (Jan-Jun 2012)

#### director age by half year



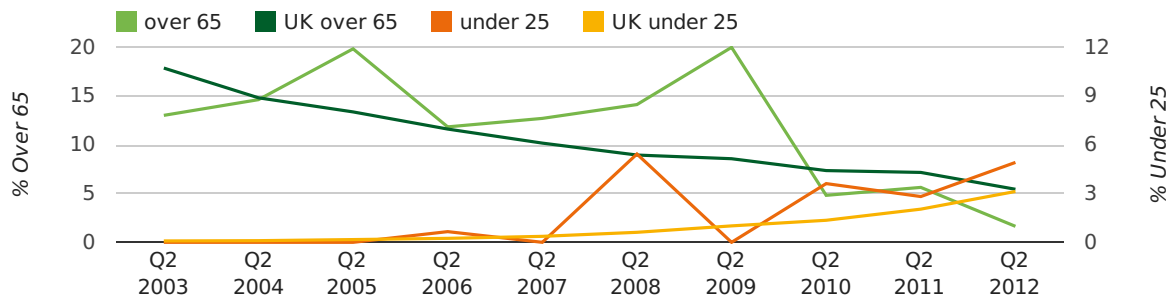
### Quarterly Data (Q2 Apr-Jun 2012)

#### director age by quarter

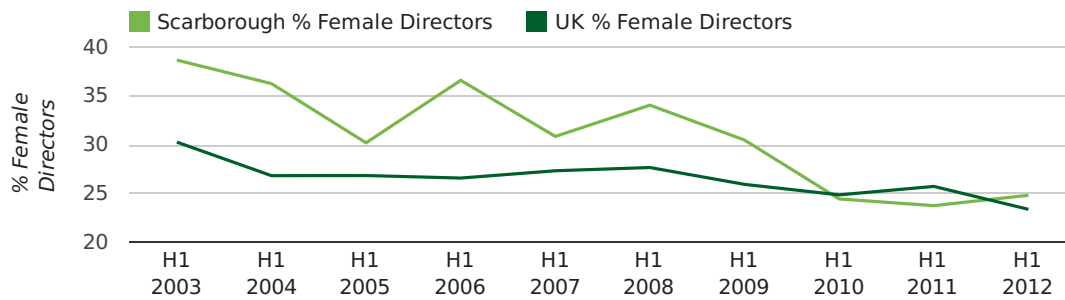


### Half Year Data (Jan-Jun 2012)

The record first half year for female directors in Scarborough was 1861 when 40.0% of all directors were female.

24.8% of all director appointments in Scarborough in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

#### director gender by half year

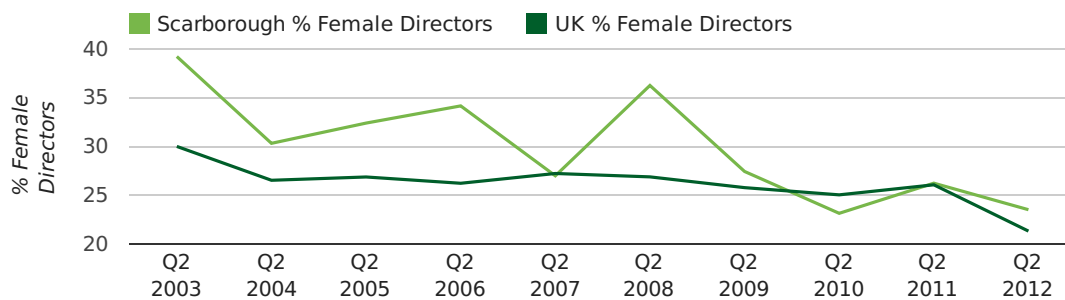


### Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Scarborough was in 1866 when 66.7% of all directors were female.

23.5% of all director appointments in Scarborough in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
