


Q4 2011 saw a new record in company registrations in Scunthorpe when compared to any previous Q4.








A total of 71 companies were dissolved in Scunthorpe during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 150 companies were added to the company register for Scunthorpe in 2011. This number represents growth of 48.1% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year








company share by year







director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)

24.1% of all director appointments in Scunthorpe in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
