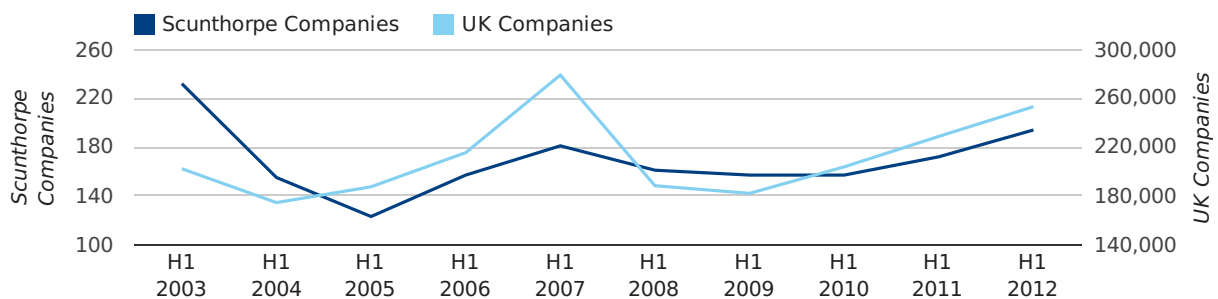
### Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 194 companies were formed in Scunthorpe. This figure is 12.8% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Scunthorpe occurred in 2003 when a total of 232 were formed.

### new companies by half year



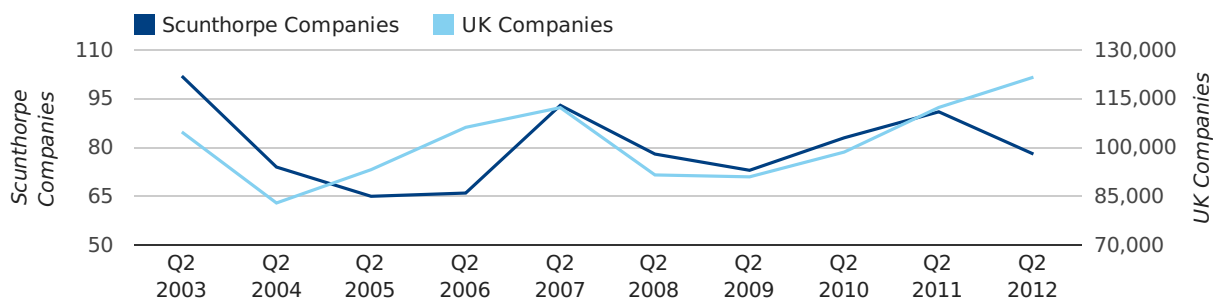
### Quarterly Data (Q2 Apr-Jun 2012)

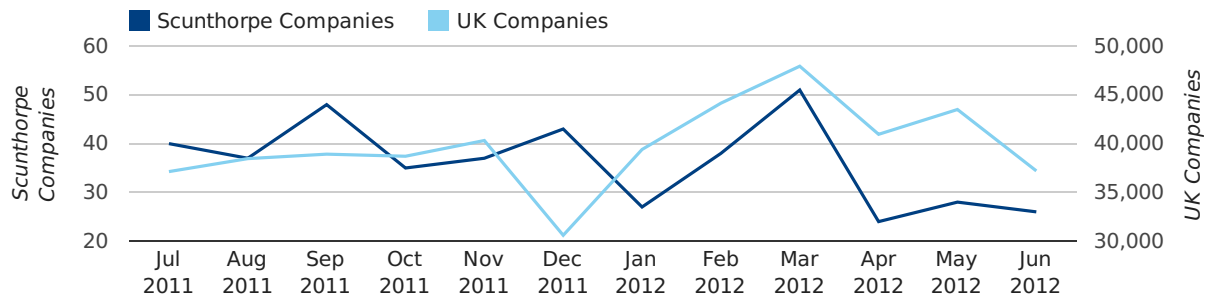

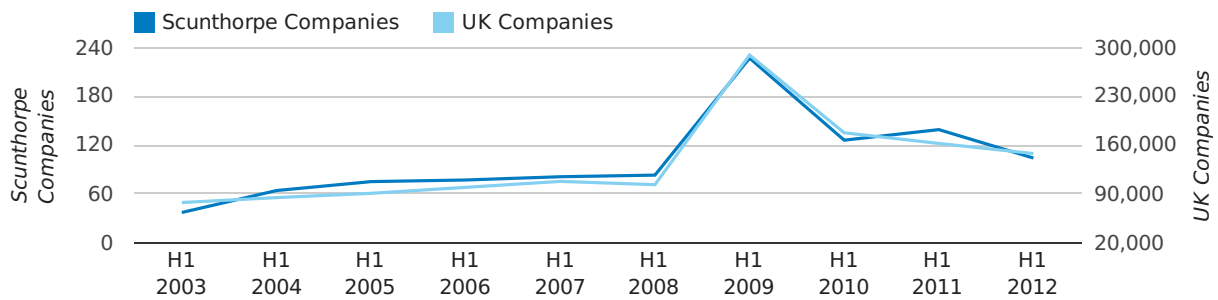
### Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 104 companies were dissolved in Scunthorpe. This figure is 25.2% lower than last year, which compares well to the UK wide change of -8.9%.

The highest total for a first half year in Scunthorpe occurred in 2009 when a total of 227 were closed.

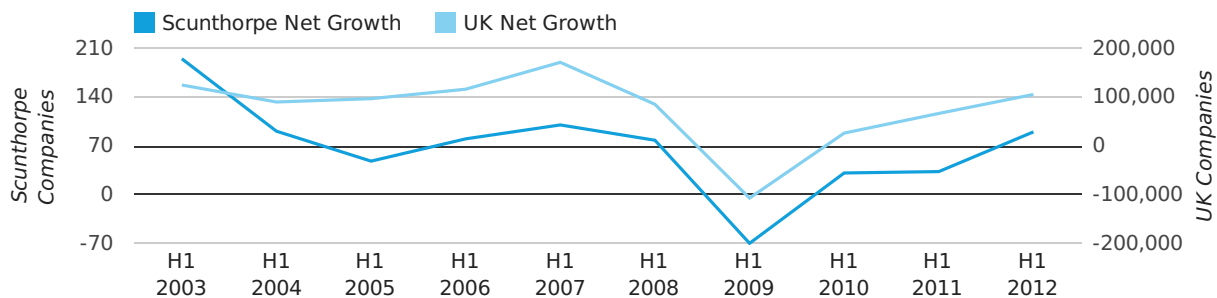

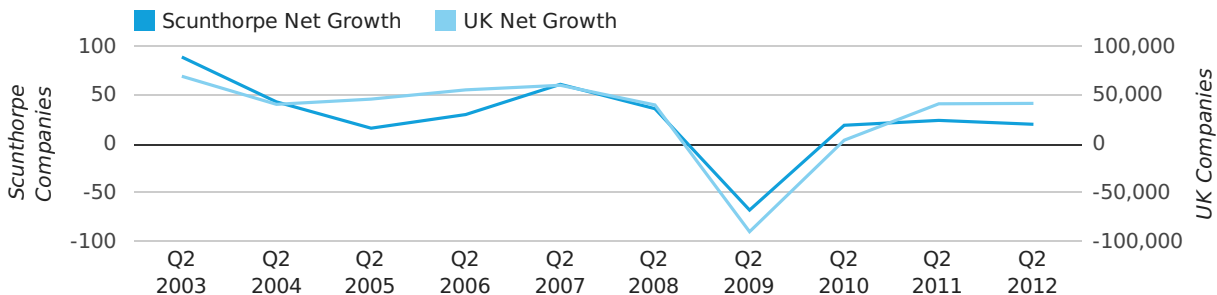
### Quarterly Data (Q2 Apr-Jun 2012)

This represents a decrease of 16.7% on the same period last year.

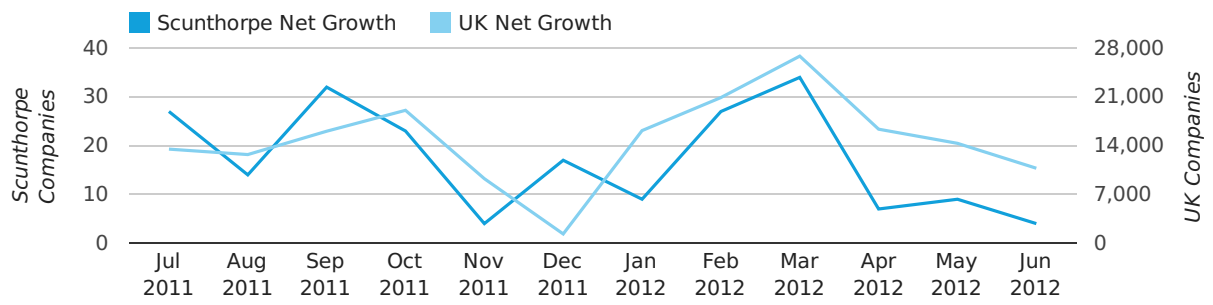

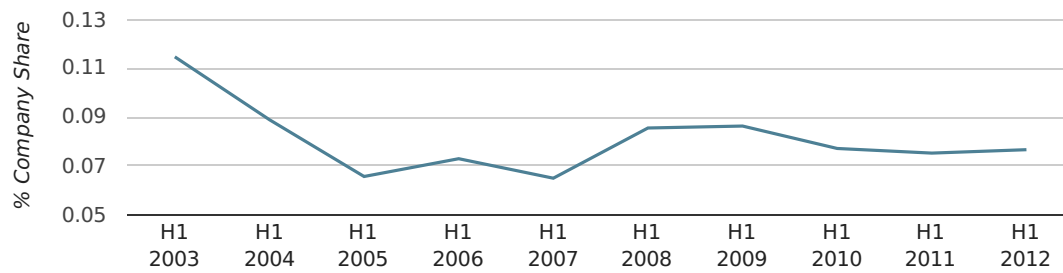

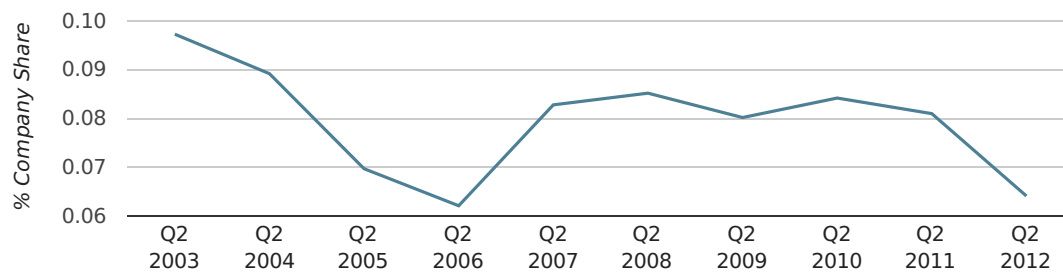

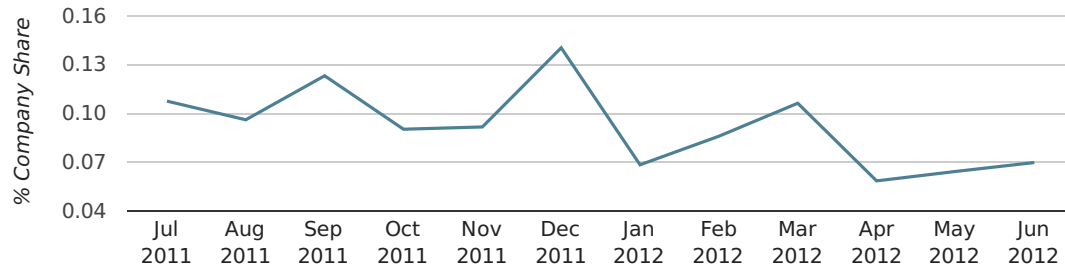

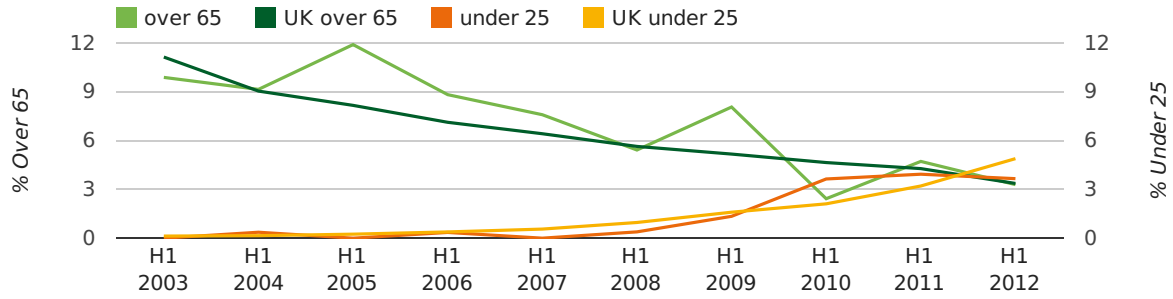
### Half Year Data (Jan-Jun 2012)

#### director age by half year



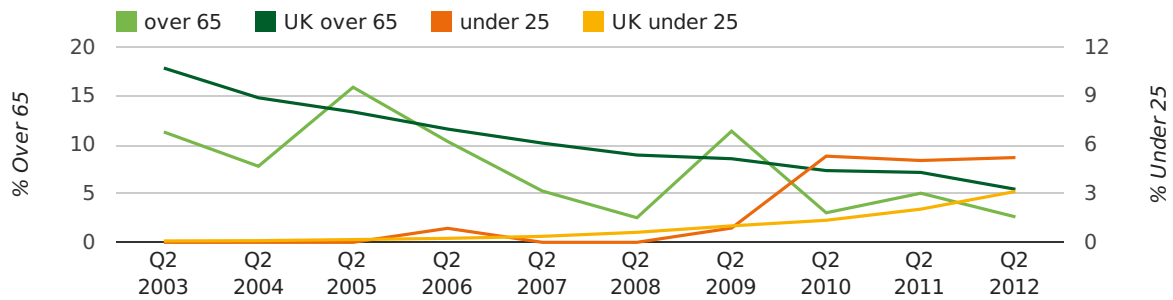
### Quarterly Data (Q2 Apr-Jun 2012)

#### director age by quarter

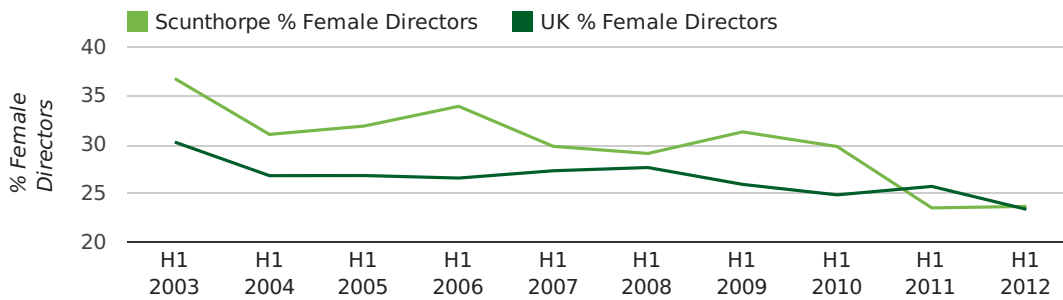


### Half Year Data (Jan-Jun 2012)

The record first half year for female directors in Scunthorpe was 1861 when 40.0% of all directors were female.

23.7% of all director appointments in Scunthorpe in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

#### director gender by half year

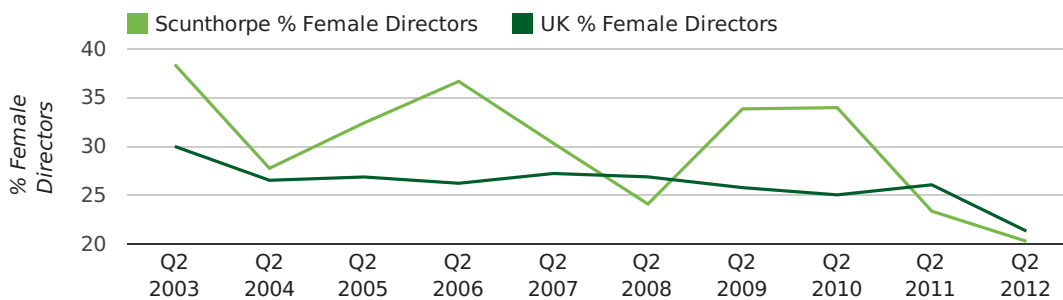


### Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Scunthorpe was in 1866 when 66.7% of all directors were female.

20.3% of all director appointments in Scunthorpe in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
