




Quarterly Data (Q4 Oct-Dec 2011)



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 12 companies were dissolved in Selby during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 59 companies were added to the company register for Selby in 2011. This number represents growth of 46.1% which compares favourably to the UK figure of 34.6%.

net growth by year



net growth by half year




Net company growth for Selby during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 26 companies.






company share by year







director age by year




director age by half year



The record second half year for female directors in Selby was 1860 when 42.9% of all directors were female.


