
The first half of 2012 saw a new record in company registrations in Sevenoaks when compared to any previous first half year.

The first half of 2012 was a record first half year for company registrations in Sevenoaks when compared to any half year in history.

In the first half of 2012 a total of 399 companies were formed in Sevenoaks. This figure is 11.5% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Sevenoaks occurred in 2012 when a total of 399 were formed.




A total of 168 companies were registered in Sevenoaks during the second quarter of 2012 (Apr 2012 - Jun 2012).


Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 265 companies were dissolved in Sevenoaks. This figure is 44.8% higher than last year, which compares badly to the UK wide change of -8.9%.

The highest total for a first half year in Sevenoaks occurred in 2009 when a total of 281 were closed.

This figure is an increase of 62.6% versus the same period last year (Q2 2011). This figure compares poorly to the UK as a whole, which saw an increase of 12.5% against the same period last year.



May 2012 saw a new record in company closures in Sevenoaks when compared to any previous May.




dissolved companies by month

net growth by half year



Net company growth for Sevenoaks during the second quarter of 2012 (Apr 2012 - Jun 2012) was 20 companies.






company share by half year





director age by half year





The percentage of directors over the age of 65 was 2.9% compared to the UK figure of 3.3%.


director age by quarter
