




Quarterly Data (Q2 Apr-Jun 2011)

A total of 93 companies were registered in Shepperton during the second quarter of 2011 (Apr 2011 - Jun 2011).






Quarterly Data (Q2 Apr-Jun 2011)





This represents an increase of 59.0% on the same period last year.






company share by half year





director age by half year






director age by quarter

director gender by half year


