


The second half of 2011 saw a new record in company registrations in Shepperton when compared to any previous second half year.




Q4 2011 saw a new record in company registrations in Shepperton when compared to any previous Q4.


#### new companies by month


Q4 2011 saw a new record in company closures in Shepperton when compared to any previous Q4.


#### dissolved companies by quarter


A total of 381 companies were added to the company register for Shepperton in 2011. This number represents growth of 99.0% which compares favourably to the UK figure of 34.6%.

#### net growth by year





#### net growth by half year





#### net growth by quarter





company share by year









## company share by month





#### director age by year




#### director age by half year

## director age by quarter





#### director gender by year




# Half Year Data (Jul-Dec 2011)

4.6% of all director appointments in Shepperton in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


## director gender by half year
