

In the first half of 2011 a total of 164 companies were formed in Shipley. This figure is 18.8% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Shipley occurred in 2007 when a total of 186 were formed.

#### new companies by half year




#### Quarterly Data (Q2 Apr-Jun 2011)

A total of 76 companies were registered in Shipley during the second quarter of 2011 (Apr 2011 - Jun 2011).





In the first half of 2011 a total of 148 companies were dissolved in Shipley. This figure is 3.3% lower than last year, which compares badly to the UK wide change of -8.6%.

The highest total for a first half year in Shipley occurred in 2009 when a total of 170 were closed.

#### dissolved companies by half year




#### Quarterly Data (Q2 Apr-Jun 2011)

A total of 77 companies were dissolved in Shipley during the second quarter of 2011 (Apr 2011 - Jun 2011).





#### net growth by half year





#### net growth by quarter











#### director age by half year





The percentage of directors over the age of 65 was 1.6% compared to the UK figure of 4.3%.


#### director age by quarter

#### director gender by half year




## Quarterly Data (Q2 Apr-Jun 2011)

The record second quarter for female directors in Shipley was in 1866 when 66.7% of all directors were female.

28.5% of all director appointments in Shipley in the second quarter of 2011 were female. This compares to a UK average of 26.1% for the same period.
