

## Half Year Data (Jul-Dec 2011)




#### new companies by half year






A total of 20 companies were dissolved in Skipton during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 74 companies were added to the company register for Skipton in 2011. This number represents growth of 49.3% which compares favourably to the UK figure of 34.6%.




## Half Year Data (Jul-Dec 2011)



#### net growth by quarter






company share by year







#### director age by year





#### director age by half year



#### director age by quarter





#### director gender by year




## Half Year Data (Jul-Dec 2011)

26.8% of all director appointments in Skipton in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


#### director gender by half year
