
The first half of 2012 saw a new record in company registrations in Smethwick when compared to any previous first half year.

Q2 2012 saw a new record in company registrations in Smethwick when compared to any previous Q2.


Q2 2012 was a record quarter for company registrations in Smethwick when compared to any quarter in history.



#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)

A total of 63 companies were dissolved in Smethwick during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 37.0% versus the same period last year (Q2 2011). This figure compares poorly to the UK as a whole, which saw an increase of 12.5% against the same period last year.


The first half of 2012 saw a new record in net growth in Smethwick when compared to any previous first half year.


Q2 2012 saw a new record in net growth in Smethwick when compared to any previous Q2.

#### net growth by quarter








company share by half year





## director age by half year




## Quarterly Data (Q2 Apr-Jun 2012)

The percentage of directors over the age of 65 was 1.8% compared to the UK figure of 3.3%.




#### director age by quarter

The record first half year for female directors in Smethwick was 1861 when 40.0% of all directors were female.

20.2% of all director appointments in Smethwick in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

## Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Smethwick was in 1866 when 66.7% of all directors were female.

18.0% of all director appointments in Smethwick in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
